**Special Resolution**

**THAT** the Model Articles for a Private Company Limited By Shares as at 28 April 2013, as circulated with this written resolution, be adopted in their entirety as the articles of association of the Company in substitution for, and to the exclusion of the Company's existing articles of association (including all provisions treated as provisions of the Company's articles of association by virtue of section 28 of the Act or paragraph 42 of schedule 2 to The Companies Act 2006 (Commencement No. 8, Transitional Provisions and Savings) Order 2008).
