

Unless otherwise agreed in writing by the Lenders any present or future statutory mortgage, standard security, floating charge or other charge granted by a Group Company to a Lender or assigned to a Lender (other than the Charges) shall not prejudice the foregoing provisions as to ranking notwithstanding any provision contained in any of the Charges or any such future charge or any rule to the contrary

1 1 Group Companies other than Johnson Marine, Johnson Shellfish and Nufish

It is hereby agreed and declared between Singers and SDT that for the purpose of this Agreement (but not further or in particular so as to prejudice or affect any rights or remedies of any of Singers and SDT against a Group Company other than Johnson Marine, Johnson Shellfish and Nufish) Singers' Charges and SDT's Charges shall rank in the following order of priority in respect of Group Companies other than (i) Johnson Marine, (ii) Johnson Shellfish and (iii) Nufish so as to ensure that all moneys received by a receiver appointed under or

otherwise realised from any of Singers' Charges and SDT's Charges shall be applied in the following manner

- all moneys received in respect of or realised out of Singers' Charges and SDT's Charges in respect of the Biomass and the Receivables shall be applied in or towards discharge of Singers' Debt,
- all moneys received in respect of or realised out of Singers' Charges and SDT's Charges in respect of the Fixed Assets shall be applied in or towards discharging the outstanding amount of SDT's Debt, and
- any surplus thereafter shall be paid to such person or persons as may be entitled to it, and for these purposes Singers and SDT shall rank pari passu as between themselves

12 Fixed Assets

It is hereby agreed between SDT, Johnson Seafarms and Johnson Sustainable Seafoods that no Fixed Assets shall be sold or encumbered by these Group Companies without the prior written consent of SDT

13 Inconsistency

It is acknowledged by all parties to this Agreement that certain provisions of the SDT's Charges and the loan documentation in respect of the SDT Debt (together the "SDT" Finance Documents") conflict with equivalent or substantially similar provisions in the Singers' Charges and the loan documentation relating to the Singers' Debt (together the "Singers' Finance Documents"). To the extent of any conflict between the terms of the Singers' Finance Documents and the SDT' Finance Documents with respect only to restrictions on incurrence of indebtedness, disposals of assets other than the Fixed Assets and granting of Encumbrances over assets other than the Fixed Assets, in each case by any Group Company, it is agreed that the terms of the Singers' Finance Documents shall prevail to the extent of any conflict, always provided that nothing in this Clause 2.3 shall allow Johnson Seafarms or Johnson Sustainable Seafoods to dispose to dispose of or grant any future Encumbrance after the date of this Agreement over any of the Fixed Assets without the prior written consent of SDT in accordance with Clause 2.2 (Fixed Assets) above

1 4 Johnson Shellfish and Nufish

It is hereby agreed and declared between Singers and SDT that for the purpose of this Agreement (but not further or in particular so as to prejudice or affect any rights or remedies of any of Singers and SDT against Johnson Shellfish and Nufish) all security conferred by SDT's Charges in respect of the assets and undertaking of Johnson Shellfish and Nufish shall rank in priority to all security granted over those assets and undertaking in favour of Singers under the Singers' Charges, in all respects irrespective of when SDT's Debt and the Singers' Debt shall have arisen and irrespective of the fact, date or time of execution, registration of any document or giving of notice to any person and so that the priority of SDT's Charges shall not be affected by any fluctuations in the monies, obligations and liabilities from time to time due, owing or incurred to SDT by any Group Company

15 Johnson Manne

It is hereby agreed and declared between Singers and SDT that for the purpose of this Agreement (but not further or in particular so as to prejudice or affect any rights or remedies of any of Singers and SDT against Johnson Marine) all security conferred by Singers' Charges in respect of the assets and undertaking of Johnson Marine shall rank in priority to all security granted over those assets and undertaking in favour of SDT under the SDT's Charges, in all respects irrespective of the fact, date or time of execution, registration of any document or giving of notice to any person and so that the priority of Singers' Charges shall not be affected by any fluctuations in the monies, obligations and liabilities from time to time due, owing or incurred to Singers by any Group Company
