MEMORANDUM OF ASSOCIATION

214546

- 1. The company's name is "Promoters Arts Network Limited".
- 2. The company's registered office is to be situated in Scotland.
- 3. The company's object is to advance the education of the public in the arts of theatre, dance, and/or other art forms in and/or from the Scottish Highlands and in furtherance thereof but not otherwise.
 - (a) To promote and/or support the presentation to the public of works of theatre, dance, music and/or other art forms which are of an objectively high class and standard.
 - (b) To promote a network of community groups and art bodies.
- 4. In furtherance of the above objects, but not otherwise, the company is established for the following ancillary purposes:-
 - (a) to carry on any other charitable purpose or objective which can be advantageously or conveniently carried on by the company by way of an extension of or in association with the objects stated in clause 3 hereof or which may be calculated directly or indirectly to advance the objectives stated in the said lastmentioned clause;
 - (b) to borrow and raise money for the furtherance of the objects of the company in such manner and on such security as the company may think fit;
 - (c) to raise funds and to invite and receive contributions from any person or persons whatsoever by way of subscription, donation or otherwise, and whether absolutely, conditionally or in trust provided that the company shall not undertake any permanent trading activities in raising funds for the abovementioned charitable objects;
 - (d) to invest the monies of the company not immediately required for the furtherance of its objects in or upon such investments, securities or property as may be thought fit, subject nevertheless to such conditions (if any) and such consents (if any) as may for the time being be imposed or required by law;
 - (e) to purchase, take on lease or in exchange, hire or otherwise acquire or deal with any real or personal property, whether heritable or moveable, and any rights or privileges and to construct, maintain and alter any buildings or erections which the company may think necessary for the promotion of its objects;
 - (f) to sell, let, mortgage, dispose of or turn to account all or any of the property or assets of the company with a view to the furtherance of its objects;





- (g) subject to clause 5 hereof to employ and pay such architects, surveyors, solicitors and other professional persons, workmen, clerks and other staff as are necessary for the furtherance of the objects of the company;
- (h) to make all reasonable and necessary provision for the payment of pensions and superannuation to or on behalf of employees and their widows and other dependants;
- (i) to subscribe to, become a member of, or amalgamate or co-operate with any other charitable organisation, institution, society or body not formed or established for purposes of profit (whether incorporated or not and whether in Great Britain, Northern Ireland or elsewhere) whose objects are wholly or in part similar to those of the company and which by its constitution prohibits the distribution of its income and property amongst its members to an extent at least as great as is imposed on the company under or by virtue of clause 5 hereof and to purchase or otherwise acquire and undertake all or part of the property, assets, liabilities and engagements as may lawfully be acquired or undertaken by the company of any such charitable organisation, institution, society or body;
- to establish and support or aid the establishment and support of any charitable trusts, associations or institutions and to subscribe or guarantee money for charitable purposes in any way connected with or calculated to further any of the objects of the company;
- (k) to do all or any of the things hereinbefore authorised either alone or in conjunction with any other charitable organisation, institution, society or body with which this company is authorised to amalgamate;
- (I) to pay all or any expenses incurred in connection with the promotion, formation and incorporation of the company;
- (m) to print and publish any newspapers, periodicals, books or leaflets that the company may think desirable for the promotion of its objects;
- (n) to do all such other lawful things as are necessary for the attainment of the above objects or any of them; provided that:-
 - in case the company shall take or hold any property which may be subject to any trusts, the company shall only deal with or invest the same in such manner as allowed by law, having regard to such trusts;
 - (ii) the company shall not support with its funds any object, or endeavour to impose on or procure to be observed by its members or others any regulation, restriction or condition which, if an object of the company, would make it a trade union;
 - (iii) in relation to any property which may come into the hands of the company as trustees under any trust (whether established by any trust deed or any scheme of court or made in pursuance of any enactment relating to educational endorsements or war charities or otherwise) nothing herein shall authorise the company to deal therewith otherwise than in accordance with the terms of the trust and with any law relevant thereto, nor shall the incorporation of the company affect the liability as an individual of any member of the management committee or governing body who may be a party to such dealings.

Declaring that this clause and the whole memorandum and articles of association of the company shall be read and interpreted as if there were embodied therein an overriding qualification to the effect that no expenditure of income by the company shall be permitted for the purpose of carrying out any activities which are not wholly charitable within the meaning of section 505 of the Income and Corporation Taxes Act 1970 or of any statutory modification or amendment thereof (which meaning shall be ascribed to the word charitable wherever used in this memorandum) and that in all cases in which activities permitted by the objects of the company are in their nature capable of being exercised for purposes which are not charitable or only partially so, as well as for purposes which are wholly charitable, the powers contained in the objects of the company shall be held to limit such activities to those which will not prejudice the charitable status of the company within the statutory meaning before mentioned.

5. The income and property of the company shall be applied solely towards the promotion of its objects as set forth in this memorandum of association and no portion thereof shall be paid or transferred, directly or indirectly, to members of the company, and no member of the management committee or governing body shall be appointed to any office of the company paid by salary or fees or receive any remuneration or other benefit in money or money's worth from the company.

Provided that nothing herein shall prevent any payment in good faith by the company:-

- (i) of reasonable and proper remuneration to any member, officer or servant of the company (not being a member of the management committee or governing body) for any services rendered to the company;
- (ii) of interest on money lent by any member of the company or of the management committee or governing body at a reasonable and proper rate per annum not exceeding 2 per cent less than the published base lending rate of a clearing bank to be selected by the management committee or governing body;
- (iii) of reasonable and proper rent for premises demised or let by any member of the company or of the management committee or governing body;
- (iv) of fees, remuneration or other benefit in money or money's worth to any company of which a member of the management committee or governing body may also be a member holding not more than one hundredth part of the capital of that company;

and

- to any member of the management committee or governing body of reasonable out-ofpocket expenses.
- 6. The liability of the members is limited.
- 7. Every member of the company undertakes to contribute such amount as may be required (not exceeding £1) to the company's assets if it should be wound up while he is a member or within one year after he ceases to be a member, for payment of the company's debts and liabilities contracted before he ceases to be a member, and of the costs, charges and expenses of winding up, and for the adjustment of the rights of the contributories among themselves.

8. If on the winding-up of the company any property remains after satisfaction of all the company's debts and liabilities, such property shall not be paid to or distributed among the members of the company but shall be transferred to some other charitable body or bodies (whether incorporated or unincorporated) whose object is altogether or in part similar to the object of the company and whose constitution restricts the distribution of income and assets among members to an extent at least as great as does Clause 5 of this Memorandum of Association.

The body or bodies to which property is transferred under the above paragraph shall be determined by the members of the company at or before the time of dissolution or, failing such determination by such court as may have or may acquire jurisdiction.

To the extent that effect cannot be given to the above provisions the relevant property shall be applied to some other charitable object or objects.

We, the subscribers to this memorandum of association, wish to be formed into a company pursuant to this memorandum.

ARTICLES OF ASSOCIATION

1. Preliminary

Regulations 2 to 35 inclusive, 54, 55, 57, 59, 82, 102 to 108 inclusive, 110, 114, 116 and 117 of Table A, shall not apply to the company but the articles hereinafter contained and, subject to the modifications hereinafter expressed, the remaining regulations of Table A shall constitute the articles of association of the company.

2. Interpretation

In regulation 1 of Table A, the definition of "the Holder" shall be omitted.

Members

The subscribers to the memorandum of association of the company and such other persons as are admitted to membership in accordance with the articles shall be members of the company. No person shall be admitted a member of the company unless he is approved by the directors. Every person who wishes to become a member shall deliver to the company an application for membership in such form as the directors require executed by him.

4. A member may at any time withdraw from the company by giving at least seven clear days' notice to the company. Membership shall not be transferable and shall cease on death.

5. Notice of general meetings

In regulation 38 of Table A-

- (a) in paragraph (b) the words "of the total voting rights at the meeting of all the members" shall be substituted for "in nominal value of the shares giving that right"; and
- (b) the words "The notice shall be given to all the members and to the directors and auditors"

shall be substituted for the last sentence.

6. Proceedings at general meetings

The words "and at any separate meeting of the holders of any class of shares in the company" shall be omitted from regulation 44 of Table A.

7. Paragraph (d) of regulation 46 of Table A shall be omitted.

8. Votes of members

On a show of hands every member present in person shall have one vote. On a poll every member present in person or by proxy shall have one vote.

9. Directors expenses

The words "of any class of shares or" shall be omitted from regulation83 of Table A.

10. Proceedings of directors

In paragraph (c) of regulation 94 of Table A the word "debentures" shall be substituted for the words "shares, debentures or other securities" in both places where they occur.

11. Minutes

The words "of the holders of any class of shares in the company" shall be omitted from regulation 100 of Table A.

12. Notices

The second sentence of regulation 11 of Table A shall be omitted.

13. The words "of the holders of any class of shares in the company" shall be omitted from regulation 113 of Table A.
