

**1 INTRODUCTION**

I, Thomas Campbell MacLennan of Tenon Recovery, 160 Dundee Street, Edinburgh, EH11 1DQ was appointed Provisional Liquidator of the company on 23 February 2004 following the presentation of a petition to Edinburgh Sheriff Court. A winding up order was subsequently made on 5 April 2004 and at the first meeting of creditors on 13 May 2004 I was appointed Liquidator.


**2 REALISATION OF ASSETS**

Sales of £12,203 were made. Book debts of £14,535 were recovered. The customer listing was sold for a total of £9,190. There was a balance in the bank of £3,718 and bank interest of £3,197 was received.

**3 OTHER MATTERS**

All statutory duties have been carried out and the outcome of the case is that there is no dividend to any class of creditor.

I am bringing the liquidation to a conclusion and am seeking my release as liquidator
