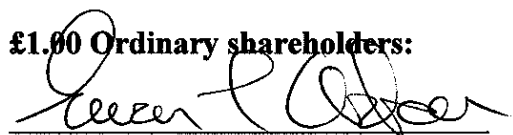
Elective Resolutions
