We have pleasure in providing an update on the progress of the Administration for the six month period ending 9 May 2011. We also enclose form 2.20B (Scot) providing formal notice to that effect.

An abstract of receipts and payments for the period 10 November 2010 to 9 May 2011 is attached at appendix 1. Other information required by rule 2.47 of the Insolvency Rules 1986 is attached at appendix 2.

Asset Realisations

The only asset of the company is an investment in a subsidiary company registered in The British Virgin Islands. This company is currently being wound up under British Virgin Islands insolvency law by local agents. At this stage we are unable to ascertain whether or not there will be any return to shareholders.

Preferential creditors

There are no preferential creditors in this matter.

Unsecured Creditors

The only unsecured creditor recorded on the statement of affairs was The Royal Bank of Scotland in respect of the shortfall in its security. To date no formal claim has been received from them.

Administrator's Remuneration

Rule 2.106 of the Insolvency Rules 1986 as amended by the Insolvency (Amendment) Rules 2003 states that the Administrators remuneration should be calculated either as a percentage of realisations or on the basis of time spent. As there are no assets the Administrators remuneration will be calculated on time costs. These are set out in appendix 3.

Creditors have the right to challenge the Administrator's remuneration and expenses under Rule 2.109 of the Insolvency Rules 1986

Future Strategy

As it seems unlikely that any funds will be available for distribution to unsecured creditors, the most appropriate exit strategy is for the company to be dissolved.

In accordance with Rule 2.47 of the Insolvency (Amendments) Rules 2003, the next progress report is due on 9 November 2011.
