

- (1) Each person listed in Schedule 1 (the "Chargors"); and
- (2) National Westminster Bank Pic as agent and trustee for the Secured Parties (the "Security Trustee").

Background

- (A) Pursuant to the Original Debenture (as defined below), the Chargors created Security over all of their assets for, amongst other things, their present and future obligations and liabilities under the Original Facilities Agreement and the other Finance Documents (as defined in the Original Facilities Agreement).
- (B) The Chargors have agreed to amend the Original Facilities Agreement to (amongst other things) increase the maximum amount of incremental facilities that may be made available pursuant to the Original Facilities Agreement.
- (C) This Supplemental Debenture is supplemental to the Original Debenture (as defined below):

This Deed witnesses as follows:

1. Definitions and interpretation

Terms defined in the Original Debenture shall, unless otherwise defined in this Supplemental Debenture or unless a contrary intention appears, bear the same meaning when used in this Supplemental Debenture and the following definitions shall apply:

"Amended Facilities Agreement" means the Original Facilities Agreement, as amended and restated by the amendment and restatement agreement entered into on or about the date of this Supplemental Debenture between amongst others (1) the Chargors and (2) the Security Trustee.

"Assigned Agreements" has the meaning given to such term in the Original Debenture (and for the avoidance of doubt, shall include any agreement in relation to which the rights thereunder have been previously assigned by a Chargor in favour of the Security Trustee as security for the Secured Obligations).

"Finance Documents" has the meaning given to such term in the Amended Facilities Agreement.

"Original Debenture" means the debenture between amongst others (1) the Chargors and (2) the Security Trustee dated 2 May 2019.

"Original Facilities Agreement" means the facilities agreement originally dated 2 May 2019 as amended on 27 September 2019, 24 February 2020 and 26 March 2021 and as amended and restated on 6 January 2022 and made between, amongst others, (1) Sunshine Care Bidco Limited as parent (the "Parent"), (2) Swanton Care & Community Limited as original borrower (the "Company"), (3) the Parent and certain of its subsidiaries as original guarantors, and (4) National Westminster Bank Plc as agent and security trustee.

"Secured Obligations" means in respect of any Chargor, all monies and liabilities now or after the date of this Deed due, owing or incurred by that Chargor to any Secured Party under the Senior Debt Documents (or any of them) in any manner and in any currency or currencies and whether present or future, actual or contingent, whether incurred solely or jointly with any other person and whether as principal or surety, together with all interest accruing on such monies and liabilities and all costs, charges and expenses incurred by any Secured Party

under any Senior Debt Document, except for any obligation which, if it were included here, would constitute unlawful financial assistance, or its equivalent in any other jurisdiction.

"Senior Debt Documents" has the meaning given to such term in the Original Debenture (and for the avoidance of doubt shall include the Amended Facilities Agreement).

1.1 Construction

- (a) Unless a contrary intention appears, sub-clause 1.2 (Construction) of the Original Debenture applies to this Supplemental Debenture, and shall be deemed to be incorporated into this Supplemental Debenture, mutatis mutandis, as though set out in full in this Supplemental Debenture, with any reference to "this Debenture" being deemed to be a reference to "this Supplemental Debenture", subject to any necessary changes.
- (b) Any references to the Security Trustee or any Receiver shall include its Delegate.

1.2 Law of Property (Miscellaneous Provisions) Act 1989

To the extent necessary for any agreement for the disposition of the Security Assets in this Supplemental Debenture to be a valid agreement under section 2(1) of the Law of Property (Miscellaneous Provisions) Act 1989, the terms of the other Senior Debt Documents and of any side letters between any parties in relation to any Senior Debt Document are incorporated into this Supplemental Debenture.

1.3 Implied covenants for title

The obligations of the Chargors under this Supplemental Debenture shall be in addition to the covenants for title deemed to be included in this Supplemental Debenture by virtue of Part I of the Law of Property (Miscellaneous Provisions) Act 1994.

1.4 Effect as a deed

This Supplemental Debenture is intended to take effect as a deed notwithstanding that the Security Trustee may have executed it under hand only.

15 Trusts

- (a) The Security Trustee holds the benefit of this Supplemental Debenture on trust for the Secured Parties in accordance with the terms of clause 18 of the Intercreditor Agreement.
- (b) The perpetuity period for any trusts created by this Supplemental Debenture is 125 years.

2. Security Assets

- 2.1 Supplemental to clause 3 (Security Assets) of the Original Debenture, as security for the payment of the Secured Obligations, each Chargor:
 - (a) charges by way of legal mortgage its interest in the Land referred to opposite its name in Schedule 2 (Land charged by way of legal mortgage) and all Premises contained on the Land;
 - (b) charges by way of fixed charge any right, title or interest which it has now or may subsequently acquire to or in any other Land (other than any real or heritable Land located in Scotland);
 - (c) mortgages or (if or to the extent that this Supplemental Debenture does not take effect as a mortgage) charges by way of fixed charge:

- (i) all Shares;
- (ii) all Investments;
- (iii) all Distribution Rights related to the Shares and the Investments (including those held for such Chargor by any nominee);
- (d) charges by way of fixed charge all Equipment in so far as it is not charged by legal mortgage under clause 2.1(a) or 2.1(b).
- (e) charges by way of fixed charge:
 - (i) its Controlled Debts;
 - (ii) all benefits, rights and security held in respect of, Controlled Debts;
 - (iii) all amounts standing to the credit of each Controlled Account held with the Security Trustee and all of its right, title and interest in and relating to each such Controlled Account;
 - (iv) all monies standing to the credit of each Account (including each Current Account listed at Schedule 4 of this Supplemental Debenture) held by the relevant Chargor with any bank, building society, financial institution or other person (other than any Controlled Account);
 - (v) all its Intellectual Property,
 - (vi) its goodwill;
 - (vii) its uncalled capital;
 - (viii) the benefit of all Authorisations it holds in relation to any Security Asset;
 - (ix) its right to receive all moneys payable under any Derivative Contract;
 - (x) all its rights under all deeds and agreements to which it is a party other than:
 - (A) the Assigned Agreements and Insurances which are effectively assigned by clauses 2.1(f)(ii) or 2.1(f)(iii); and
 - (B) the Derivative Contracts;
- (f) assigns absolutely:
 - (i) all amounts standing to the credit of each Controlled Account held with a person other than the Security Trustee and all of its rights, title and interest in and relating to each such Controlled Account:
 - (ii) all its rights and interests under the Assigned Agreements to which it is party;
 - (iii) all its rights and interests in the Insurances; and
- (g) charges by way of floating charge all its present and future business, undertaking and assets which are not effectively mortgaged, charged by way of fixed charge or assigned under this clause 2 or charged under any Standard Security.
- The floating charge created by sub-clause 2.1(g) is a qualifying floating charge for the purpose of paragraph 14 of Schedule B1 to the Insolvency Act.

- 2.3 Sub-clauses 5.1 and 5.3 of the Original Debenture apply to the floating charge created by sub-clause 2.1(g).
- 2.4 Subject to sub-clause 2.5 below, the obtaining of a moratorium under Part A1 of the Insolvency Act 1986, or anything done with a view to obtaining such a moratorium (including any preliminary decision or investigation), shall not be an event causing any floating charge created by this Supplemental Debenture to crystallise or causing restrictions which would not otherwise apply to be imposed on the disposal of any asset by a Chargor or a ground for the appointment of a Receiver.
- 2.5 Sub-clause 2.4 above does not apply in respect of any floating charge referred to in subsection (4) of section A52 of Part A1 of the Insolvency Act 1986.

3. Appointment of Receivers

The Security Trustee is not entitled to appoint a Receiver solely as a result of the obtaining of a moratorium or anything done with a view to obtaining a moratorium under Part A1 of the Insolvency Act 1986 (including any preliminary decision or investigation), other than in respect of a floating charge referred to in subsection (4) of section A52 of Part A1 of the Insolvency Act 1986.

4. Incorporation

The provisions of each of:

- (a) clause 2 (Covenant to pay);
- (b) clauses 3.6(b) and (c) (Controlled Accounts held with Security Trustee);
- (c) clause 3.8 (Accounts),
- (d) clause 3.14(b) (Assigned Agreement);
- (e) clause 3.15(b) (Insurances);
- (f) clause 3.18 (Trust) to clause 5.1 (Conversion of Floating Charge) (inclusive); and
- (g) clause 5.3 (Automatic conversion) to clause 11.1(a) (Method of appointment and removal) (inclusive); and
- (h) clause 11.1(c) (Method of appointment and removal) to clause 27 (Counterparts) (inclusive).

of the Original Debenture apply to this Supplemental Debenture as though they were set out in full in this Supplemental Debenture except that references to "this Debenture" in the Original Debenture are to be construed as references to "this Supplemental Debenture".

5. Continuation

- 5.1 Except insofar as supplemental hereby, the Original Debenture will remain in full force and effect.
- 5.2 The Chargor agrees that the execution of this Supplemental Debenture shall in no way prejudice or affect the security granted by it (or the covenants given by it) under the Original Debenture.
- References in the Original Debenture to "this Deed" and expressions of similar import shall be deemed to be references to the Original Debenture as supplemented by this Supplemental Debenture and to this Supplemental Debenture.

This Supplemental Debenture is a Transaction Security Document and a Finance Document for the purposes of the Amended Facilities Agreement.

6. Governing law

This Supplemental Debenture and any non-contractual obligations arising out of or in connection with it are governed by English law.

7 Jurisdiction

- 7.1 The courts of England have exclusive jurisdiction to settle any dispute arising out of or in connection with this Supplemental Debenture (including a dispute relating to the existence, validity or termination of this Supplemental Debenture or any non-contractual obligation arising out of or in connection with this Supplemental Debenture) (a "Dispute").
- 7.2 The Parties agree that the courts of England are the most appropriate and convenient courts to settle Disputes and accordingly no Party will argue to the contrary.
- 7.3 This clause is for the benefit of the Security Trustee only. As a result, the Security Trustee shall not be prevented from taking proceedings relating to a Dispute in any other courts with jurisdiction. To the extent allowed by law, the Security Trustee may take concurrent proceedings in any number of jurisdictions.
