### Introduction

### **Appointment**

I was appointed liquidator by a meeting of members on 5 December 2019.

### **Assets**

The assets of the company consisted of cash at bank and a loan due from Bearsden Golf Club. The cash at bank was ingathered from Bank of Scotland and distributed to Mrs Doreen Adams as the sole shareholder, and the company debtor (Bearsden Golf Club) was assigned to Mrs Doreen Adams from Boston Lettings Limited.

### **Statutory Work**

I notified the Registrar of Companies and the Accountant in Bankruptcy of all appointments. I also reported to the Registrar of Companies and the Accountant in Bankruptcy on the progress of the winding up as required.

All meetings and appointments were advertised as required by the Insolvency Act.

### Liquidator's Fees
