

All or any monies and liabilities which shall for the time being (and whether on or at any time after demand) be due, owing or incurred in whatsoever manner to Taylor Woodrow by the Company in terms of the Facility Letter, whether actually or contingently, solely or jointly and whether as principal or surety and whether or not Taylor Woodrow shall have been an original party to the relevant transaction, and including (but only to the extent due to Taylor Woodrow in terms of the Facility Letter) interest, discount, commission and other lawful charges or expenses which Taylor Woodrow may in the course of its business charge or incur in respect of any of those matters, and so that interest shall be computed and compounded according to the usual rates and practice of Taylor Woodrow as well after as before any demand made or decree obtained under the Charge.

2. Restrictions and Ranking

- 2.1 The Company agrees that it shall be prohibited from granting or creating subsequent to the Execution Date any fixed security or any other floating charge (as defined by the Companies Act 1985) having priority over or ranking pari passu with the Charge, otherwise than in favour of Taylor Woodrow.
- 2.2 In the event that the Company grants or creates any fixed security or floating charge in breach of the prohibition in Clause 2.1 above, the Charge shall rank in priority to that fixed security or floating charge.

3. <u>Definitions</u>

In the foregoing M410 (Scot) and this Paper Apart references to the following shall have the following meanings ascribed to them:-

"Facility Letter"

means the facility letter from Taylor Woodrow addressed to the Company dated 18 July 2003 and accepted by the Company on 25 July 2003 as the same may be amended, varied, supplemented, restated, substituted or novated from time to time including, for the avoidance of doubt, any increases (1) of the facilities offered and/or (2) to the relative charges and interest rates.
