## Trustees' report

#### Structure, Governance and Management

#### Nature of governing document

The governing document for the charity is a memorandum and articles of association, and the charity is constituted as a company limited by guarantee.

#### Decision making structure

The Trustees decide the strategic direction for the charity and approve the Strategic Plan and the annual budget. The Chief Executive is delegated day to day management and implementation responsibility for the strategy and expenditure within the budget limits. Progress is monitored through quarterly Finance/HR sub-group meetings which include the office bearers and report to the full Board of Trustees.

#### Appointment of trustees

Members of the Board of Trustees are categorised as individuals. Institutions, organisations or other bodies are not eligible to be members of the Board of Trustees.

The number of members of the Board of Trustees shall not be less than six and no more than twelve.

Two non-voting Observers from key statutory stakeholders attend meetings of the Board of Trustees.

#### Policies and procedures for induction and training of trustees

New Trustees are inducted by the Chairman and Chief Executive of the Charity and are provided with key documents outlining their governance roles and responsibilities.

#### Risk management

The Board of Trustees has adopted a process for the ongoing assessment of possible risks to the organisation and has developed actions and countermeasures to reduce these risks and their likely impact. The risk framework is subject to regular review and biannual updating. The Board is therefore satisfied that systems and actions are in place to mitigate our exposure to major risk.

#### Objectives and activities

The company's purpose is to aid the relief of poverty, hardship, suffering and distress among partners, children and dependents of persons who suffered a legal restriction on their liberty in any penal or correctional establishment or through any means whatsoever.

Families Outside is the only national organisation that works exclusively on behalf of families affected by imprisonment in Scotland. We exist because imprisonment of a family member has a negative impact on the social, emotional, financial and (for children and young people) educational development of the remaining family members, leading to disadvantage, exclusion and the risk of perpetuation of cycles of crime and imprisonment.

Families Outside works to mitigate the effects of imprisonment on children and families - and consequently to reduce the likelihood of reoffending - through support and information for families and for those working with them. We seek to ensure that these families are afforded the recognition, respect and compassion they need to alleviate the disadvantages they face due to this experience, also enabling them, where appropriate, to provide support to their relative in prison and on release.

#### Objectives and activities (continued)

The charity's long term key objectives are to ensure that:

- Families affected by imprisonment can readily access appropriate information and support at the time they
  need it. This in turn will improve their experience with the criminal justice system and mitigate its impact
  on them:
- Policy makers, decision makers, and relevant service providers will be well-informed about the issues facing families affected by imprisonment. They will recognise prisoners' families within their remit and take the needs of these families into account in the decisions they make and the services they provide;
- Families Outside will provide a sustainable and viable service as long as the demand for its work is evident.

In order to achieve these long term key objectives, our targets include the following actions:

- Raise awareness and influence policy and practice regarding families affected by imprisonment;
- Provide and increase direct support and information to families;
- Support and collaborate with other organisations to support families; and
- Ensure viability, effectiveness and impact of the organisation.

These aims are essential and ongoing and are facilitated by specific, often ongoing, activities which Families Outside are engaged in throughout the year. These activities help us in achieving our long term key objectives and include:

#### Ongoing core activities:

- Running the Families Outside national freephone Support & Information Helpline, supporting approximately 1,700+ families and professionals per annum;
- Direct service provision to prisoners' families through our Family Support Workers. Extending to the
  whole of Scotland for the first time, the four members of staff have an annual caseload well in excess of
  the targeted 200 families in total per annum;
- Training/awareness-raising to audiences such as prison staff, police, staff and volunteers at other voluntary sector organisations, social workers, social work and psychology students, Children's Panel members, faith communities, the National Health Service and more. Our awareness-raising has expanded to include sessions with secondary school students through the Life/Time project (outlined below). We also work with the Scottish Government's Getting it Right for Every Child (GIRFEC) implementation teams to promote identification and support of children/young people through health workers and schools. Overall, Families Outside provided training to approximately 2,000 individuals in 2010/11, with continuing requests in 2011/12;
- Development of policy and practice alongside national and local statutory organisations, contributing through consultations and steering & advisory groups relevant to families.
- Publicity distributed to families affected by imprisonment and a wide range of professional contacts including courts/prisons/CABS/social work departments. This includes leaflets, professional packs, DVDs and access to our website, which this year introduced a new 'Kids' section. Currently, we average 2,800 website hits per week (up from 2,000 at this time last year) and have ongoing requests for hardcopy publicity;
- Regional contact through our Regional Coordinators who link with prisons, Community Justice
  Authorities and locally-based statutory and voluntary support services. This ensures our influence
  spreads throughout Scotland, allowing us to act effectively as a national umbrella organisation for
  services offering support to families affected by imprisonment;
- Support for other organisations working with families through cross-referral, training, evaluation and sharing of information and practice, most recently through the establishment, coordination and chairmanship of the Criminal Justice Family Support Network; and
- Exhibitions/presentations/workshops at conferences and other events.

#### Objectives and activities (continued)

Projects, publications and research activities:

- Continuation of the 'Routes out of Prison' partnership project with the Scottish Prison Service, Apex and the Wise Group. This includes direct support work with families and continuation of innovative work with prisoners and their partners through a programme from Relationships Scotland;
- Continuation of The Life/Time project following its success in 2009/10. This is an initiative run by the
  Scottish Prison Service and in collaboration with the police, Scottish Court Service, the fire service, The
  Red Cross, and ourselves, among other partners, to make young people in secondary schools aware of the
  impact of offending.
- Publication of our own research into the impact of parental imprisonment on children, in collaboration with Scotland's Commissioner for Children and Young People;
- Further development of an e-Learning package to make our training readily accessible throughout Scotland;
- At the suggestion of Lothian & Borders Police, creation of a stencil to advertise the Helpline on the walls
  and ceilings of police cells, court cells and prison waiting areas and now in use in several parts of
  Scotland;
- Publication of three new information sheets for families as well as a new awareness-raising leaflet for families and professionals, with the support of the Routes out of Prison partnership;
- Research into projects that offer support to prisoners and families including Circle and Artlink Central;
- Hosting of two final-year social work students from The Netherlands to develop a tool to conduct Child & Family Impact Assessments.

#### Achievements and performance

Families Outside's profile and reputation is well-established, with positive relationships built with key statutory and voluntary agencies in the criminal justice sector and beyond. This has been aided by the opportunity to contribute actively to a range of Scottish Government and SPS policy and practice initiatives.

The Chief Executive contributes to the Scottish Government's Reducing Reoffending strategy through input to key Project Implementation Boards that direct the implementation of recent legislation. The Regional Coordinators and Chief Executive also work closely with the Scottish Prison Service and Scotland's eight Community Justice Authorities (CJAs) to assist in the development and implementation of policy and practice with regard to prisoners' families, including chairmanship of Family Outcome Groups for the two CJAs that have them. We have also developed closer links with the police and courts, with the result that we now deliver training and awareness sessions to police and court staff in some areas.

Families Outside's Support & Information Helpline continues to provide a direct service to families in need and to the professionals who work with them. It also underpins the organisation's influencing activity through provision of current, direct information about the experiences of people with family members caught up in the criminal justice system. The installation of a more robust Helpline database has improved our use of the data collected from calls to the Helpline, allowing us to disseminate this in accessible and appropriate formats to a broad range of policy and practice audiences in criminal justice and other relevant areas.

Our provision of direct support to families of prisoners continues to move from strength to strength. Referrals to our western Family Support Worker doubled in the first quarter of her second year as awareness and utilisation of the service increased. A second Family Support Worker joined her to supplement this work and ensure all families could access support. Our eastern-based worker maintained the high level of referrals in her second year, and a worker for the Northern and Tayside regions started work in November 2010, based primarily at the Perth Prison Visitors' Centre.

#### Achievements and performance (continued)

Finally, Families Outside hosted two significant events to support professionals who work with children and families of prisoners. One was a training event from Carol Shapiro of Family Justice (USA), focusing on engagement with families of prisoners and following up from her presentation at our conference the previous year. The second was the 'Big Draw' Family Friendly Prison Challenge in October 2010, in conjunction with Action for Prisoners' Families, followed by a celebration event for participating Scottish prisons in February 2011. This event shared practice from the prisons and recognised their achievements, including a presentation of certificates by Tam Baillie (Scotland's Commissioner for Children and Young People) and Susan Philipsz (2010 Turner Prize Winner) and closing comments from the Chief Executive of the Scottish Prison Service.

#### Financial review

The Statement of Financial Activities shows that Families Outside ended the year with a surplus of £59,104, which compares with a surplus of £2,499 for the previous year. This surplus is made up of the following:

- a restricted deficit of £2,465 relating to (i) the depreciation expense for equipment previously acquired
  from funding received from the Scottish Government and (ii) inclusion of the remaining restricted income
  from 2010/11 provided by the Glasgow Community Justice Authority to be used in 2011/12 for the
  development of an e-learning package;
- an unrestricted surplus of £61,569. This means that our unrestricted funds have increased from £59,270 as at 31 March 2010 to £120,839 at 31 March 2011.

Funding from The Brook Trust was received in 2010/11 and as such, under SORP 2005, this has been recognised in the current financial year. However the funds will be carried forward in unrestricted reserves to 2011/12 when, with agreement from The Brook Trust, Families Outside will make use of the funds.

The financial position and the review of financial systems and controls of the organisation are monitored on a quarterly basis by a Finance/HR sub-group, which reports to the Board of Trustees.

With funds from these organisations, we have continued to meet the main objectives of Families Outside through the core activities and projects of the charity as detailed above.

We would also like to thank the The Michael & Shirley Hunt Charitable Trust, Includem, the Friends of Families Outside and everyone else who made donations and supported our activities throughout the year.

In addition, we were very grateful to have received a grant from The Gannochy Trust. This funding will be applied to the coming financial year 2011/12.

#### Plans for future periods (continued)

#### Reserves Policy

The unrestricted fund balance is £120,839, of which £118,268 represents the free reserves of the organisation arising from past operating results. The Board would like to apply 'best practice' and build up the free reserves to a level which would cover about 3 to 6 months operating activity, a target which is still to be achieved.

#### Plans for future periods

In the forthcoming 2011/12 financial year, Families Outside will commit itself to the following activities:

- Host a national conference in November 2011 with up to 200 delegates.
- Contribute to the UN Committee on the Rights of the Child General Day of Discussion on Children with Imprisoned Parents.
- Continue to promote the Helpline as a resource for families and for professionals who can call on our specialist knowledge to assist them in their own work with families and extend this resource to full-time provision.
- Continue support to families of offenders throughout Scotland.
- Continue to train staff from a wide range of backgrounds who come into contact with families e.g. the Scottish Prison Service, staff at private prisons, Children's Panel members, NHS, police, schools, courts, social workers, and students of social work and forensic psychology.
- Complete development of an e-Learning resource for professionals in justice, education, health and other sectors.
- Continue to promote the use and development of prison Visitors' Centres as a wider community resource, and often as the only means of accessing this vulnerable group.
- Continue to promote the development of play provision in prisons and deliver training to prison staff in this area, incorporating the work of Kids VIP.
- Continue direct development of policy and practice through participation in the national and regional SPS
  Children & Family Strategy Groups, Community Justice Authority forums, the Scottish Working Group
  on Women's Offending, the Scottish Consortium on Crime and Criminal Justice and the Scottish
  Criminal Justice Voluntary Sector Forum as well as lobbying of Members of the Scottish Parliament and
  engagement with international bodies such as Eurochips.
- Continue our research and consultancy through the monitoring and support of a number of initiatives across Scotland on behalf of the Robertson Trust and other organisations. We also conduct, commission and host research to lobby for change.
- Build on the number of Friends of Families Outside to encourage the sharing of good practice and provide opportunities for professionals and family members to come together, talk and listen in a safe environment
- Produce In Brief 6 'Prisoners' Families: The Value of Family Support Work'.

### **Auditors**

A resolution to appoint auditors for the ensuing year will be proposed at the annual general meeting in accordance with Section 485 of the Companies Act 2006.

The trustees' report is prepared in accordance with the special provisions relating to small companies in Part 15 of the Companies Act 2006.

# Statement of trustees' responsibilities

#### Notes

(forming part of the financial statements)

#### 1 Accounting policies

#### Basis of accounting

The financial statements have been prepared under the historical cost convention, and are in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008), the Statement of Recommended Practice - Accounting and Reporting by Charities: Statement of Recommended Practice (SORP) issued in 2005; the Charities and Trustee Investment (Scotland) Act 2005 and the Companies Act 2006.

The Board consider it is appropriate to draw up the accounts on a going concern basis as sufficient funding has been secured to cover operational costs for the next 12 months. The Board is actively seeking funds for the following 12 months.

#### Incoming resources

- Incoming resources are included in the year in which they are receivable, which is when the company becomes entitled to the resource.
- Grants receivable are credited in the year for which they are received.
- Income that relates to future periods as a result of donor imposed conditions specifying the time period has been treated as deferred income.
- Income relating to the acquisition of fixed assets has been recognised as restricted income against which the appropriate depreciation will be charged.

#### Resources expended

All expenditure is included on an accruals basis and is recognised when there is a legal or constructive obligation to pay for expenditure. The company is not registered for VAT and accordingly costs are shown gross of irrecoverable VAT. Where directly attributable, resources expended are allocated to the relevant functional category. Overhead and support costs are allocated to functional category on the basis of direct staff costs in each area of activity.

#### Cost of generating funds

The costs of generating funds include expenditure incurred in supporting the charity and incurred on fundraising initiatives

#### Charitable activities

The costs of charitable activities include expenditure incurred in supporting the charity and its objectives as set out in the directors' report.

#### Governance costs

Governance costs are those incurred in connection with the, organisational administration and compliance with constitutional and statutory requirements.

#### Fixed assets and depreciation

Tangible fixed assets are stated at cost less depreciation. Assets below £200 are not capitalised but are expensed in the year they are incurred. Depreciation is calculated so as to write off the cost of an asset, less its estimated residual value, over the useful economic life of that asset as follows:

Equipment - 25% straight line

#### Pensions

The company contributes to employees' individual pension plans. The amounts charged against the income and expenditure account represent the contributions to the defined contribution scheme and to individual pension plans in respect of the accounting period.

## 1 Accounting policies (continued)

#### Leases

Operating lease rentals are charged to the profit and loss account on a straight line basis over the period of the lease.

#### **Funds**

Unrestricted funds are donations and other incoming resources receivable or generated for the objects of the company without further specified purpose and are available as general funds.

Restricted funds are to be used for specific purposes as laid down by the donor. Expenditure which meets these criteria is charged to the fund, together with a fair allocation of management and support costs.
