

#### BETWEEN:-

- (1) MREF SHEFFIELD LIMITED (Company number SC268072) whose registered office is at 15 Atholl Crescent, Edinburgh, EH3 8HA (the "Chargor") and
- (2) ACCOR UK BUSINESS & LEISURE HOTELS LIMITED whose registered office is at 1 Shortlands, Hammersmith, London W6 8DR (the "Chargee").

#### WHEREAS:

- (A) By the Debenture the Chargor created fixed and floating charges over all of its property, assets and undertaking as security for the Secured Liabilities (as defined in the Debenture).
- (B) In accordance with the Debenture, the Chargor has agreed to grant a supplemental legal charge over the Property in favour of the Chargee on the terms of this Supplemental Legal Charge.

#### IT IS AGREED as follows:

#### 1. INTERPRETATION

In this deed:

"Debenture" means the debenture dated 31 December 2013 and made by the Chargor in favour of the Chargee as the same may be amended and restated or modified or supplemented from time to time and any documents which are ancillary, supplemental or referred to therein; and

"Property" means the property specified in Schedule 1 to this deed.

"Subordination Deed" means the subordination deed 31 December 2013 between the Chargee, the Chargor and Bank of Scotland plc

1.2 Interpretation

Unless otherwise defined in this deed, words, expressions and the principles of construction used in the Debenture shall have the same meaning and effect in this deed.

#### 2. DESIGNATION

- 2.1 The Chargor enters into this deed pursuant to Clause 6 (Further Assurance) of the Debenture.
- 2.2 This deed is supplemental to the Debenture and is designated a Finance Document.
- 2.3 Prior to the Senior Discharge Date, the terms of this deed shall be subject to the terms of the Subordination Deed and in the case of any inconsistency between this Deed, the Debenture and the Subordination Deed, the Subordination Deed shall prevail.
- 2.4 For the purposes of Section 2 of the Law of Property (Miscellaneous Provisions) Act 1989, the terms of any Finance Document to which the Chargee and the Chargor are parties (other than this Supplemental Legal Charge) are incorporated in this Supplemental Legal Charge.

#### 3. COVENANT TO PAY

The Chargor hereby covenants that it will on demand pay to the Chargee all or any of the Secured Liabilities when due.

- 4.1 As continuing security for the payment and discharge of the Secured Liabilities, without prejudice to the terms of the Debenture and all rights and interests arising under or pursuant thereto, the Chargor with full title guarantee charges to the Chargee:
  - 4.1.1 by way of legal mortgage all of its right, title and interest from time to time in the Property and the Land thereon; and
  - by way of fixed charge all other interests in the Property to the extent not effectively charged by Clause 4.1.1.

#### 5. APPLICATION TO THE LAND REGISTRY

The Chargor and the Chargee apply to the Land Registry for a restriction in the following terms to be entered into on the register of the title to the Property:

"No disposition of the registered estate by the proprietor of the registered estate or by the proprietor of any registered charge, not being a charge registered before the entry of this restriction, is to be registered without a written consent signed by the proprietor for the time being of the charge dated [ ] in favour of the Chargee referred to in the charges register (Form P)".

#### 6. INCORPORATION OF DEBENTURE

The provisions of the Debenture shall apply to and be deemed to be incorporated in this deed as if set out herein in full, *mutatis mutandis*, except that references to "this Debenture" shall be construed as references to this Supplemental Legal Charge and references to the "Charged Property" shall be construed as references to the Property.
