



REPORT to the Final Meetings of Members and Creditors to be held on 24 February 2014 at 11.00am and 11.15am respectively within the offices of Scott-Moncrieff, 25 Bothwell Street, Glasgow G2 6NL

Further to my appointment as Liquidator at the meeting of members and creditors on 12 November 2013, I now present my Report on the case.

Attached is a copy of my intromissions covering the period from the date of my appointment to 17 January 2014.

Costs were incurred in interviewing the directors and members of the company, preparing various notices, minutes and resolutions relative to the winding up of the company, preparing circular letters in order to convene the meeting of creditors, compiling a Report and Statement of Affairs to be tabled at the meeting and dealing with various creditors of the company.

After the meeting of the creditors, a report on the outcome was circulated and my appointment as Liquidator was duly advertised and notified to the Registrar of Companies and the Accountant in Bankruptcy. Additionally, a return has been prepared and submitted to the Department of Trade and Industry regarding the conduct of the directors of the company under the Company Directors Disqualification Act 1986.

All assets have now been realised and I intend to close the administration of the case.

There were sufficient funds to allow a dividend payment of 0.91p in the £ to the only ordinary unsecured creditor.
