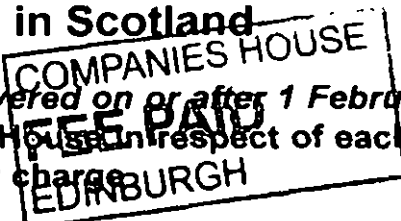

#### Notes
