1. An overview of the Administration

The Proposals

The Administrators identified that the objective of the administration, as set out in the Proposals approved on 23 September 2016, was to achieve a better result for the Company's creditors as a whole than would be likely if the Company had been wound up (without first being in administration).

The objective was achieved as the company was part of a group and sales of parts of the business and assets in those other companies was achieved.

It was anticipated that the Company would exit from administration by moving to dissolution.

Implementation of the Proposals

The Administrations of the other group companies are continuing but no further realisations are expected in this company and the administration can now be brought to an end.

Extension of period of administration

To avoid the automatic termination of the administration on the first anniversary, the period of administration was extended by a resolution of the creditors to 18 July 2018.

2. Progress of the Administration in the Period

Work undertaken during the Period

Attached at **Appendix C** is a receipts and payments account detailing both transactions for the Period and also cumulatively for the whole period of the administration.

Investigations

Part of my duties included carrying out proportionate investigations into what assets the Company has, including any potential claims against directors or other parties, and what recoveries could be made. I reviewed the Company's books and records and accounting information, requested further information from the directors, and invited creditors to provide information on any concerns they had concerning the way in which the Company's business had been conducted.

Exiting the administration

In accordance with the Proposals the administration will be exited by way of the administrators ceasing to act and the company moving to dissolution three months after the date on which the requisite notice is filed with the Registrar of Companies.

3. Outcome for creditors

Initial estimated outcome for creditors

The Proposals anticipated that there would be no funds available to any class of creditor.

4. Administrators' Remuneration, Disbursements and Expenses

Administrators' remuneration

The Proposals stated that the Administrators' remuneration would be calculated on a time cost basis. The Administrators' fees have been fixed on that basis by secured creditors and preferential creditors.

As shown on the receipts and payments account attached at Appendix C, a total of £4,541 excluding VAT, has been drawn from the funds available. This is the amount of fees fixed for the whole period of the administration.

Administrators' disbursements

The Administrators' disbursements are a recharge of actual costs incurred by the Administrators on behalf of the Company. Mileage payments made for expenses relating to the use of private vehicles for business travel, which is directly attributable to the insolvency estate, are paid by FRP Advisory at the HMRC approved mileage rate prevailing at the time the mileage was incurred.

The expenses of the Administration

The total expenses incurred by the Administrators are included in the cumulative figures in the receipts and payments account attached at **Appendix C**.


