Directors' Report for the year ended 31 December 2021

The Directors present their annual report together with the audited financial statements of SLCP (General Partner ESP CAL) Limited ("the Company") for the year ended 31 December 2021.

The Directors have taken advantage of the small companies exemption provided by Section 414B of the Companies Act 2006 and have not prepared a Strategic Report.

Business review and future developments

The Company's principal activity is to act as a General Partner of a Limited Partnership (ESP Golden Bear General Partner Limited Partnership) ("the GP LP"), which is the General Partner of ESP Golden Bear Europe Fund ("the Fund"), whose activity is to make private equity investments, primarily in Europe. The Company has entered into a management agreement with abrdn Capital Partners LLP ("aCP") (formerly SL Capital Partners LLP), authorising it to manage the business of the Funds.

The Company is part of abrdn plc ("abrdn plc" or, together with its subsidiaries, "the abrdn Group"). There are no plans to change the principal activity of the Company.

Principal risks and uncertainties

The management of the business and execution of the Company's strategy are subject to a number of risks.

The abrdn Group, of which the Company is a part, has an Enterprise Risk Management ("ERM") framework comprising three lines of defence; the first being day-to-day risk management, including identification and mitigation of risks and maintaining appropriate controls; the second being oversight from the abrdn Group Risk and Compliance function, which reports to the Chief Risk Officer; and the third being the Internal Audit function, reporting to the Chief Internal Auditor, which independently verifies systems of control.

The ERM framework underpins risk management throughout the abrdn Group, including the Company, which has evolved to ensure it keeps pace with industry best practice and risk profile of the abrdn Group. Improvements in 2021 include strengthening the risk appetite framework by introducing new risk tolerances to support governance and risk management, extending and refining risk taxonomy to help describe risk more accurately and reviewing the abrdn Group policy framework and policy register.

The principal risks and uncertainties facing the Company are integrated into the principal risks of the abrdn Group and are therefore not managed separately. The principal risks and uncertainties of abrdn plc, which include those of the Company, are detailed below:

Coronavirus (COVID-19)

COVID-19 has continued to impact the operating environment of the abrdn Group during 2021. Great resilience has been shown in dealing with the effects of the pandemic and the continued management of its market, operational and financial impacts in order to deliver the vector business plans, of which the Company is a part of, and enhancement of client focus.

The further lifting of restrictions in the UK has allowed the abrdn Group to take the next step towards 'blended working' as the default arrangement for employees. Offices will remain the primary place to go when physical interaction with colleagues is required to collaborate and connect

Strategic risk

These are risks that could prevent the achievement of strategic aims and successfully delivering business plans. These could include failing to meet client expectations, poor strategic decision-making, poor implementation or failure to adapt. The launch of the single global brand was an important step to clear up confusion that existed across multiple brands previously. These risks have been managed through assessing emerging risks so that action can be taken in a timely and proportionate manner to mitigate these, including detailed stakeholder engagement plans to manage the transition to the new brand and ensuring each business unit has a clear organic growth strategy.

Financial risk

This is the risk of having insufficient resources, suffering losses from adverse markets or the failure or default of counterparties. It could be influenced by inflows and outflows, global market trends, as well as margins on investment mandates. Capital is held against identified risks which are reviewed on an ongoing basis.

Directors' Report for the year ended 31 December 2021 (continued)

Principal risks and uncertainties (continued)

Third party management

Activities to suppliers are outsourced with specialist capabilities which means there is exposure to the risk of third parties failing to deliver in line with contractual obligations. It is the abrdn Group's responsibility to make sure these firms deliver with continued focus to streamline delivery and reduce complexity. In 2021 there were extensive preparations to adopt the European Banking Authority's guidelines on outsourcing across the supplier base. Maintaining strong relationships with suppliers is key and during 2021 a programme to rationalise the supplier base and strengthen the oversight of suppliers was completed. The abrdn Group's Third Party Code of Conduct requires third parties to acknowledge their best practice responsibilities.

Going concern

The Board's assessment of going concern is underpinned in Company forecasts that model severe market shocks to ensure the Company could continue to satisfy ongoing operating requirements. Based on their assessment the Board is satisfied that the Company has and will maintain sufficient resources to meet its liabilities as they fall due for at least 12 months from the date of approval of the financial statement. Further information is available in Note 1.

Dividends

The Directors recommended and paid dividends of £nil in 2021 (2020: £nil) to the Company's immediate parent, namely abrdn CP (Holdings) Limited (formerly SLCP Holdings) Limited.

Political donations

It is the Company's policy not to make donations for political purposes.

Independent auditor

The Independent Auditor, KPMG LLP, has indicated their willingness to continue in office.

Disclosure of information to the auditors

Each director has taken steps that they ought to have taken as a director in order to make themselves aware of any relevant audit information and to establish that the Company's auditor is aware of that information. The Directors confirm that there is no relevant information that they know of and of which they know the auditor is unaware.

Modern slavery act

As a global investment company, abrdn plc wants to do all it can to help tackle human trafficking, forced labour, bonded labour and child slavery by focusing on its operations, supply chain and investment process. abrdn plc has published a modern slavery statement, reinforcing its commitment to this important issue. Statement of Directors' Responsibilities

- assess the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern, and
- use the going concern basis of accounting unless they either intend to liquidate the Company or to cease operations, or have no realistic alternative but to do so.

Independent Auditor's Report to the Members of SLCP (General Partner ESP CAL) Limited

Opinion

We have audited the financial statements of SLCP (General Partner ESP CAL) Limited ('the Company') for the year ended 31 December 2021, which comprise the Profit and Loss Account, Balance Sheet, Statement of Changes in Equity, and Notes to the Financial Statements, including the accounting policies note 1.

In our opinion the financial statements:

- give a true and fair view of the state of the Company's affairs as at 31 December 2021 and of its result for the year then ended;
- have been properly prepared in accordance with UK accounting standards, including FRS 101 Reduced Disclosure Framework; and
- have been prepared in accordance with the requirements of the Companies Act 2006.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (UK) ("ISAs (UK)") and applicable law. Our responsibilities are described below. We have fulfilled our ethical responsibilities under, and are independent of the Company in accordance with, UK ethical requirements including the FRC Ethical Standard. We believe that the audit evidence we have obtained is a sufficient and appropriate basis for our opinion.

Going Concern

The directors have prepared the financial statements on the going concern basis as they do not intend to liquidate the company or to cease its operations, and as they have concluded that the Company's financial position means that this is realistic. They have also concluded that there are no material uncertainties that could have cast significant doubt over its ability to continue as a going concern for at least a year from the date of approval of the financial statements ("the going concern period"). In our evaluation of the directors' conclusions, we considered the inherent risks to the company's business model and analysed how those risks might affect the company's financial resources or ability to continue operations over the going concern period.

Our conclusions based on this work:

- we consider that the directors' use of the going concern basis of accounting in the preparation of the financial statements is appropriate; and
- we have not identified, and concur with the directors' assessment that there is not, a material uncertainty related to events or conditions that, individually or collectively, may cast significant doubt on the company's ability to continue as a going concern for the going concern period.

However, as we cannot predict all future events or conditions and as subsequent events may result in outcomes that are inconsistent with judgements that were reasonable at the time they were made, the above conclusions are not a guarantee that the company will continue in operation.

Fraud and breaches of laws and regulations - ability to detect

Identifying and responding to risks of material misstatement due to fraud

To identify risks of material misstatement due to fraud ("fraud risks") we assessed events or conditions that could indicate an incentive or pressure to commit fraud or provide an opportunity to commit fraud. Our risk assessment procedures included:

- Enquiring of directors and management as to the Company's high-level policies and procedures to prevent and detect fraud, as well as whether they have knowledge of any actual, suspected or alleged fraud; and
- Reading Board minutes to assess for any discussion of fraud.

We communicated identified fraud risks throughout the audit team and remained alert to any indications of fraud throughout the audit.

As required by auditing standards, and taking into account our overall knowledge of the control environment, we perform procedures to address the risk of management override of controls, in particular the risk that management may be in a position to make inappropriate accounting entries. We substantively tested any material post-closing entries and, based on the results of our risk assessment procedures and understanding of the process, no further high-risk journal entries or other adjustments were identified.

On this audit, we have rebutted the fraud risk related to revenue recognition as the calculation of revenue is non-judgemental and straightforward, with limited opportunity for manipulation. We did not identify any additional fraud risks.

Identifying and responding to risks of material misstatement due to non-compliance with laws and regulations

We identified areas of laws and regulations that could reasonably be expected to have a material effect on the financial statements from our general commercial and sector experience, through discussion with the Directors and other management (as required by auditing standards), and from inspection of the Company's regulatory and legal correspondence, and discussed with the Directors and other management the policies and procedures regarding compliance with laws and regulations.

We communicated identified laws and regulations throughout our team and remained alert to any indications of non-compliance throughout the audit.

The potential effect of these laws and regulations on the financial statements varies considerably.

Firstly, the Company is subject to laws and regulations that directly affect the financial statements including financial reporting legislation (including related companies legislation), distributable profits legislation, and taxation legislation and we assessed the extent of compliance with these laws and regulations as part of our procedures on the related financial statement items.

Whilst the Company is subject to many other laws and regulations, we did not identify any others where the consequences of non-compliance could have a material effect on amounts or disclosures in the financial statements.

Auditing standards limit the required audit procedures to identify non-compliance with these laws and regulations to enquiry of the Directors and inspection of regulatory and legal correspondence, if any. Therefore if a breach of operational regulations is not disclosed to us or evident from relevant correspondence, an audit will not detect that breach.

Independent Auditor's Report to the Members of SLCP (General Partner ESP CAL) Limited (continued)

Context of the ability of the audit to detect fraud or breaches of law or regulation

Owing to the inherent limitations of an audit, there is an unavoidable risk that we may not have detected some material misstatements in the financial statements, even though we have properly planned and performed our audit in accordance with auditing standards. For example, the further removed non-compliance with laws and regulations is from the events and transactions reflected in the financial statements, the less likely the inherently limited procedures required by auditing standards would identify it.

In addition, as with any audit, there remained a higher risk of non-detection of fraud, as these may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal controls. Our audit procedures are designed to detect material misstatement. We are not responsible for preventing non-compliance or fraud and cannot be expected to detect non-compliance with all laws and regulations.

Directors' Report

The Directors are responsible for the Directors' Report. Our opinion on the financial statements does not cover that report and we do not express an audit opinion thereon.

Our responsibility is to read the Directors' Report and, in doing so, consider whether, based on our financial statements audit work, the information therein is materially misstated or inconsistent with the financial statements or our audit knowledge. Based solely on that work:

- we have not identified material misstatements in the Directors' Report;
- in our opinion the information given in that report for the financial year is consistent with the financial statements; and
- in our opinion that report has been prepared in accordance with the Companies Act 2006.

Matters on which we are required to report by exception

Under the Companies Act 2006 we are required to report to you if, in our opinion:

- adequate accounting records have not been kept, or returns adequate for our audit have not been received from branches not visited by us; or
- the financial statements are not in agreement with the accounting records and returns; or
- certain disclosures of directors' remuneration specified by law are not made; or
- we have not received all the information and explanations we require for our audit; or
- the Directors were not entitled to take advantage of the small companies exemption from the requirement to prepare a strategic report.


Auditor's responsibilities

Notes to the Financial Statements for the year ended 31 December 2021

1 Accounting policies

Summary of significant accounting policies and key accounting estimates

The following accounting policies have been applied consistently to all years presented when dealing with items which are considered material in relation to the Company's financial statements.

Basis of preparation

The Company meets the definition of a qualifying entity under Application of Financial Reporting Requirements 100 as issued by the Financial Reporting Council. Accordingly, the financial statements for year ended 31 December 2021 have been prepared in accordance with FRS 101 as issued by the Financial Reporting Council.

Summary of disclosure exemptions

In these financial statements, the Company has applied the exemptions available under FRS 101 in respect of the following disclosures:

- International Accounting Standard ("IAS") 1 Presentation of Financial Statements requirement for comparative period reconciliations for share capital;
- IAS 1 Presentation of Financial Statements disclosures in respect of capital management;
- IAS 7 Statement of Cash Flows and related notes;
- IAS 8 Accounting Policies requirement to disclose the effects of new but not yet effective International Financial Reporting Standards ("IFRSs");
- IFRS 15 Revenue from Contracts with Customers; and
- IAS 24 Related Party disclosures in respect of transactions with wholly owned subsidiaries.

As the consolidated financial statements of abrdn plc include the equivalent disclosures, the Company has also taken the exemption under FRS 101 available in respect of the following disclosures:

- Certain disclosures required by IFRS 7 Financial Instrument Disclosures.

The Company is a wholly owned subsidiary of abrdn plc which prepares consolidated financial statements and is therefore exempt from the requirement to prepare consolidated accounts by virtue of section 400 of the Companies Act 2006.

Notes to the Financial Statements for the year ended 31 December 2021 (continued)

1 Accounting policies (continued)

Going concern

The Company's business activities, together with the factors likely to affect its future development and financial position, are set out in the Directors' Report.

The Company traded during the period but exists to make no profit or loss. This is because all regulated investment management activity pertaining to the vehicle is delegated to another abrdn Group undertaking. Consequently any profits or losses in the Company are absorbed by the delegated investment management undertaking. Amounts payable to the delegated investment management undertaking are net of operating costs, so these would be reduced should the Company incur additional operating costs. Consideration has also been given to the going concern assessment of the abrdn Group.

Changes in accounting policy

No new standards, interpretations and amendments effective for the first time from 1 January 2021 have had an impact on the Company.

Revenue recognition

The Company's primary source of revenue is profit sharing from the underlying Limited Partnership. Profit share is generated through the management profit share that is paid by the Funds to the GP LP. Revenue is recognised as the service is provided and when it is probable that the profit share will be received.

Administrative expenses

Administrative expenses are recognised on an accruals basis.

Foreign currency transactions and balances

(i) Functional currency

Items included in the financial statements are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The financial statements are presented in pounds sterling, which is the Company's presentational and functional currency.

(ii) Transactions and balances

Transactions in foreign currencies are translated to the functional currency at the exchange rate ruling at the date of the transaction. At each balance sheet date, monetary assets and liabilities denominated in foreign currencies are translated at the exchange rate ruling at the balance sheet date and any exchange differences arising are taken to the profit and loss account.

Financial assets

(i) Amortised cost

These instruments are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. These instruments are included in current assets and consist of amounts owed by abrdn Group undertakings. These instruments are initially recognised at fair value, net of any transaction costs, and subsequently at amortised cost using the effective interest rate method.

The Company has adopted trade date accounting. Accordingly, a financial asset is recognised on the date the Company commits to its purchase and derecognised on the date on which the Company commits to its sale.

1 Accounting policies (continued)

Financial liabilities

Amortised cost

These instruments include amounts owed to abrdn Group undertakings and amounts owed to the GP LP. These instruments are initially recognised at fair value and subsequently at amortised cost using the effective interest rate method.

2 Critical accounting judgements and key sources of estimation uncertainty

The preparation of the financial statements can necessitate the use of key estimates and judgements. These estimates and judgements can affect the reported amounts of assets and liabilities, contingent or otherwise, at the balance sheet date as well as affecting the reported profit or loss for the year. There are not considered to be any critical estimates.

Report of the General Partner

The General Partner, ESP Golden Bear General Partner Limited Partnership, presents the audited financial statements for ESP Golden Bear Europe Fund ("the Fund") for the year ended 31 December 2021.

Structure of the Fund

The Fund is a Limited Partnership, established in Scotland, United Kingdom ("U.K."). The Fund held its first and final close on 29 August 2007, admitting two Limited Partners with aggregate commitments of €515 million. Following a Limited Partner transfer on 30 September 2016, the Fund now has 7 Limited Partners.

ESP Golden Bear General Partner Limited Partnership is the General and Founder Partner of the Fund and has contributed €57 to the Fund as a carried interest partner. The Founder Partner, General Partner and Limited Partners are collectively referred to "the Partners" in these financial statements.

The structure of the Fund is detailed further in note 1 to the financial statements.

Directors of the General Partner

Please refer to the financial statements of SLCP (General Partner ESP Cal) Limited for the names of the Directors. Ian Harris resigned as Director on 1 October 2021. Stewart Hay and Roger Pim resigned on 22 February 2022.

Distributions

Distributions of €57,141,264 (2020: €30,266,564) were made during the year of which €566,885 (2020: €268,881) was temporary return of capital, which is recallable.

COVID-19

The outbreak of the Novel Coronavirus (COVID-19), declared by the World Health Organization as a "Global Pandemic" on the 11th March 2020, continues to impact many aspects of daily life and the global economy. On 11th November 2021, a new variant (Omicron), was detected and led to a tightening of restrictions globally in an effort to manage the impact of this highly transmissible variant. The full impact and severity of disease caused by Omicron has yet to be fully determined and understood.

Many sectors of the economy saw positive growth during 2021 as global economies came out of lockdown and rebounded strongly. Travel, movement and operational restrictions were implemented, loosened and re-implemented to a lesser extent by many countries throughout 2021 and this pattern has continued into 2022. In some cases, "lockdowns" have been applied – in varying degrees – to reflect further 'waves' of COVID-19. While these may imply a new stage of the crisis, they are not unprecedented in the same way as the initial impact.

The pandemic and the measures taken to tackle COVID-19, including the development and roll out of vaccines and booster doses, continues to affect economies globally with certain sectors being impacted harder than others. The success of vaccine programmes continue to have a major impact on the speed and nature of economic recovery but the timing and form of the recovery remains uncertain, particularly with the emergence of new strains of COVID-19.

The General Partner, as part of the abrdn plc group (formerly known as Standard Life Aberdeen plc group), is continuing to utilise business continuity and resilience processes with the objective of mitigating the impact of COVID-19. Please refer to note 3.2 for the General Partner's assessment of the Fund's ability to continue as a going concern.

Events after the reporting date

The Fund made a permanent distribution to the Limited Partners of €17,255,129 after the reporting date.

Post the year-end date, on 24th February 2022, Russia launched a military offensive in Ukraine resulting in widespread sanctions on Russia and heightened security and cyber threats.

As at the date of the approval of the financial statements the Fund did not hold any assets in Ukraine or Russia. The Fund's key suppliers do not have operations pertaining to the Fund in Ukraine or Russia.

Report of the General Partner (continued)

Events after the reporting date (continued)

The situation in the region is rapidly evolving and the General Partner and the Investment Manager continue to monitor the situation carefully and will take whatever steps are necessary and in the best interests of the Fund's Investors. This includes but is not limited to ensuring that the requirements of all international sanctions are adhered to, managing the assets of the Fund proactively to best mitigate risk and ensuring that the Investment Manager and other key suppliers continue to operate all protections, protocols and monitoring of heightened cyber threats. At the time of writing, there is not expected to be any significant long term adverse direct impact from the conflict in Ukraine on the assets, processes and procedures of the Fund.

The General Partner has identified no other significant events after the reporting date.

Results, activities and future developments

The results for the year are set out in the Statement of Comprehensive Income on page 8. A description of the principal activity of the Fund is provided in note 1 to the financial statements.

The Manager's Report for the Fund, which is issued separately, contains detailed analysis of each of the Fund's Investments, together with commentary on the economic climate and how this impacts the private equity market.

Disclosure of information to auditor

At the date of this report, the General Partner confirms that:

- As far as the General Partner is aware, there is no relevant information of which the Fund's auditor is unaware; and
- The General Partner has taken all the steps that it ought to have taken as a General Partner in order to make it aware of any relevant audit information and to establish that the Fund's auditor is aware of that information.

Independent auditor

The General Partner has reappointed KPMG LLP as auditor to the Fund in accordance with Section 485 of Companies Act 2006.


Data protection

abrdn Capital Partners LLP ("the Manager") has implemented measures that it believes are necessary in order to comply with the General Data Protection Regulation.

Strategic report

The Fund is considered as "small" under Section 414B of The Companies Act 2006 (Strategic Report and Directors' Report) Regulations 2013 and it is therefore exempt from preparing a strategic report.

Statement of General Partner's Responsibilities in respect of the Report of the General Partner and the financial statements

The General Partner is responsible for preparing the Report of the General Partner and the financial statements in accordance with applicable law and regulations.

The Partnerships (Accounts) Regulations 2008 require the General Partner to prepare financial statements for each financial year in accordance with Part 15 and Chapter 1 of Part 16 of the Companies Act 2006. Under that law, the General Partner have elected to prepare the financial statements in accordance with UK Accounting Standards and applicable law (UK Generally Accepted Accounting Practice), including FRS 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland.

Under Company law, the General Partner must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the Qualifying Partnership and of the profit or loss of the Qualifying Partnership for that period.

In preparing these financial statements, the General Partner is required to:

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent;
- state whether applicable UK accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements;
- assess the Qualifying Partnership's ability to continue as a going concern, disclosing, as applicable, matters related to going concern; and
- use the going concern basis of accounting unless they either intend to liquidate the Qualifying Partnership or to cease operations, or have no realistic alternative but to do so.

The General Partner is responsible for keeping adequate accounting records that are sufficient to show and explain the Qualifying Partnership's transactions and disclose with reasonable accuracy at any time the financial position of the Qualifying Partnership and enable them to ensure that the financial statements comply with the Companies Act 2006 as applied to qualifying partnerships by The Partnerships (Accounts) Regulations 2008. They are responsible for such internal control as they determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error, and have general responsibility for taking such steps as are reasonably open to them to safeguard the assets of the Qualifying Partnership and to prevent and detect fraud and other irregularities.

Independent Auditor's Report to the Partners of ESP Golden Bear Europe Fund

Opinion

We have audited the financial statements of ESP Golden Bear Europe Fund ("the Qualifying Partnership") for the year ended 31 December 2021 which comprise the Statement of Comprehensive Income, the Statement of Financial Position, the Statement of Changes in Net Assets Attributable to Partners, the Statement of Cash Flows and related notes, including the accounting policies in note 3.

In our opinion the financial statements:

- give a true and fair view of the state of the Qualifying Partnership's affairs as at 31 December 2021 and of its profit for the year then ended;
- have been properly prepared in accordance with UK accounting standards, including FRS 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland; and
- have been prepared in accordance with the requirements of the Companies Act 2006 as applied to qualifying partnerships by The Partnerships (Accounts) Regulations 2008.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (UK) ("ISAs (UK)") and applicable law. Our responsibilities are described below. We have fulfilled our ethical responsibilities under, and are independent of the Qualifying Partnership in accordance with, UK ethical requirements including the FRC Ethical Standard. We believe that the audit evidence we have obtained is a sufficient and appropriate basis for our opinion.

Going concern

The General Partner has prepared the financial statements on the going concern basis as they do not intend to liquidate the Qualifying Partnership or to cease its operations, and as they have concluded that the Qualifying Partnership's financial position means that this is realistic. They have also concluded that there are no material uncertainties that could have cast significant doubt over its ability to continue as a going concern for at least a year from the date of approval of the financial statements ("the going concern period").

In our evaluation of the General Partner's conclusions, we considered the inherent risks to the Qualifying Partnership's business model and analysed how those risks might affect the Qualifying Partnership's financial resources or ability to continue operations over the going concern period.

Our conclusions based on this work:

- we consider that the General Partner's use of the going concern basis of accounting in the preparation of the financial statements is appropriate; and
- we have not identified, and concur with the General Partner's assessment that there is not, a material uncertainty related to events or conditions that, individually or collectively, may cast significant doubt on the Qualifying Partnership's ability to continue as a going concern for the going concern period.

However, as we cannot predict all future events or conditions and as subsequent events may result in outcomes that are inconsistent with judgements that were reasonable at the time they were made, the above conclusions are not a guarantee that the Qualifying Partnership will continue in operation.

Fraud and breaches of laws and regulations – ability to detect

Identifying and responding to risks of material misstatement due to fraud

To identify risks of material misstatement due to fraud ("fraud risks") we assessed events or conditions that could indicate an incentive or pressure to commit fraud or provide an opportunity to commit fraud. Our risk assessment procedures included:

- enquiring of the General Partner as to the Partnership's policies and procedures to prevent and detect fraud as well as enquiring whether they have knowledge of any actual, suspected or alleged fraud;
- reading minutes of meetings of those charged with governance; and
- considering performance based remuneration for the General Partner.

We communicated identified fraud risks throughout the audit team and remained alert to any indications of fraud throughout the audit.

Independent Auditor's Report to the Partners of ESP Golden Bear Europe Fund (continued)

Fraud and breaches of laws and regulations – ability to detect (continued)

Identifying and responding to risks of material misstatement due to fraud (continued)

As required by auditing standards, and taking into account our overall knowledge of the control environment, we performed procedures to address the risk of management override of controls, in particular the risk that management may be in a position to make inappropriate accounting entries. On this audit we do not believe there is a fraud risk related to revenue recognition because revenue streams are simple in nature with respect to accounting policy choice, and are easily verifiable to external data sources or agreements with little or no requirement for estimation from management. We did not identify any additional fraud risks.

We performed procedures including identifying journal entries to test based on risk criteria and comparing the identified entries to supporting documentation. These included material post-closing journals.

Identifying and responding to risks of material misstatement due to non-compliance with laws and regulations

We identified areas of laws and regulations that could reasonably be expected to have a material effect on the financial statements from our general commercial and sector experience and through discussion with the General Partner (as required by auditing standards), and discussed with the General Partner the policies and procedures regarding compliance with laws and regulations.

We communicated identified laws and regulations throughout our team and remained alert to any indications of non-compliance throughout the audit.

The potential effect of these laws and regulations on the financial statements varies considerably.

The partnership is subject to laws and regulations that directly affect the partnership including financial reporting legislation (including relevant companies legislation) and we assessed the extent of compliance with these laws and regulations as part of our procedures on the related financial statement items.

Whilst the partnership is subject to many other laws and regulations, we did not identify any others where the consequences of non-compliance alone could have a material effect on amounts or disclosures in the financial statements.

Context of the ability of the audit to detect fraud or breaches of law or regulation

Owing to the inherent limitations of an audit, there is an unavoidable risk that we may not have detected some material misstatements in the financial statements, even though we have properly planned and performed our audit in accordance with auditing standards. For example, the further removed non-compliance with laws and regulations is from the events and transactions reflected in the financial statements, the less likely the inherently limited procedures required by auditing standards would identify it.

In addition, as with any audit, there remained a higher risk of non-detection of fraud, as these may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal controls. Our audit procedures are designed to detect material misstatement. We are not responsible for preventing non-compliance or fraud and cannot be expected to detect non-compliance with all laws and regulations.

General Partner's report

The General Partner is responsible for the General Partner's report. Our opinion on the financial statements does not cover that report and we do not express an audit opinion or, except as explicitly stated below, any form of assurance conclusion thereon.

Our responsibility is to read the General Partner's report and, in doing so, consider whether, based on our financial statements audit work, the information therein is materially misstated or inconsistent with the financial statements or our audit knowledge. Based solely on that work:

- we have not identified material misstatements in that report;
- in our opinion the information given in the General Partner's report for the financial year is consistent with the financial statements; and
- in our opinion that report has been prepared in accordance with the Companies Act 2006.

Independent Auditor's Report to the Partners of ESP Golden Bear Europe Fund (continued)

Matters on which we are required to report by exception

Under the Companies Act 2006 as applied to qualifying partnerships we are required to report to you if, in our opinion:

- adequate accounting records have not been kept, or returns adequate for our audit have not been received from branches not visited by us; or
- the financial statements are not in agreement with the accounting records and returns; or
- certain disclosures of members' remuneration specified by law are not made; or
- we have not received all the information and explanations we require for our audit; or
- the General Partner was not entitled to take advantage of the small companies exemption, as applied to qualifying partnerships, from the requirement to prepare a strategic report.

We have nothing to report in these respects.


Auditor's responsibilities

Notes to the Financial Statements

1. Fund background

The Fund is a Limited Partnership registered in Scotland, U.K. and was established on 29 August 2007 (the "Effective Date"). The Fund held a first and final closing on 29 August 2007 with total commitments of €515,000,057 from two Limited Partners and the General Partner. The Limited Partners' capital contributions equal 0.0001% of their total commitment. Following a Limited Partner transfer on 30 September 2016, the Fund has 7 Limited Partners. Commitments to Fund Investments can be drawn at any time and the Fund is required to draw down loan commitments from Limited Partners in order to cover these.

ESP Golden Bear General Partner Limited Partnership is the General and Founder Partner of the Fund and has contributed €57 to the Fund as a carried interest partner. The Manager of the Fund is abrdn Capital Partners LLP (formerly known as SL Capital Partners LLP), which is authorised and regulated by the Financial Conduct Authority and is a U.S. Securities and Exchange Commission registered investment advisor based in Edinburgh, U.K. The Fund has no employees.

The Fund was formed for the purpose of investing in Fund Investments and Co-investments, together "Investments". For investment purposes, total commitments are treated separately as 'A' and 'B' commitments as follows:

'A' commitments comprise €412 million of total commitments. The Manager intends to invest at least 80% of the 'A' commitments in Large Fund Investments with a fund size of between €350 million and €2.5 billion and up to 20% in Co-investments.

'B' commitments comprise €103 million of total commitments. The Manager intends to invest the 'B' commitments in Small Fund Investments with a fund size of €350 million or less.

The Fund is established for a term of ten years from the end of the Investment Period, subject to two one year extensions. The investment period for Fund Investments and Co-Investments was five years from the Effective Date and has now expired. The initial term of the Partnership is due to expire on 29 August 2022. It is the intention of the General Partner to use the additional two one year extensions under the terms of the Limited Partnership Agreement to extend the life of the Fund to 29 August 2024.

2. Statement of compliance

- (ii) the consequential Amendments to FRS 102 The Financial Reporting Standard in the UK and Republic of Ireland – UK exit from the European Union
- (iii) the Amendments to FRS 102 The Financial Reporting Standard in the UK and Republic of Ireland – COVID-19-related rent concessions beyond 30 June 2021.

There has been no material impact following the adoption of the Amendments on accounting policies for classification, recognition and measurement of items within the financial statements or on disclosures within these.

3. Summary of significant accounting policies

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

3.1 Basis of preparation

These financial statements are prepared on a going concern basis, under the historical cost convention, as modified by the recognition of certain financial assets and liabilities measured at fair value through profit or loss. The financial statements are presented in Euro ("€"), which is also the Fund's functional currency. The preparation of financial statements in conformity with FRS 102 requires the use of certain critical accounting estimates. It also requires the General Partner to exercise its judgement in the process of applying the Fund's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant, are disclosed in note 4.

3.2 Going concern

The General Partner has made an assessment of the Fund's ability to continue as a going concern and is satisfied that the Fund has the resources to continue in business for at least 12 months from the date of approval of the financial statements. In preparing these financial statements, the General Partner has considered the uncertainty created by COVID-19, focusing specifically on:

- the level of liquid resources, including cash and cash equivalents, which exceed the level of creditors. The Manager regularly monitors the Fund's cash position to ensure sufficient cash is held to meet liabilities as they fall due;
- the level of undrawn commitments available from Limited Partners, which are due on demand in accordance with the Limited Partnership Agreement, are sufficient to meet future obligations to Fund Investments and working capital requirements; and
- the effectiveness of the General Partner's operational resilience processes, including the ability of key outsourcers to continue to provide services.

The Partnership's term is due to expire within 12 months of the approval of the financial statements, however, under the terms of the Limited Partnership Agreement, the General Partner can extend the life per the extension powers granted to them for two additional one year periods, which they intend to enact at the next extension date. Accordingly, the financial statements have been prepared on a going concern basis.

3.3 Income, expenses, gains and losses

All income and expenses, inclusive of realised gains and losses, are accounted for on an accruals basis in the Statement of Comprehensive Income.

Net income, gains and losses of the Fund are allocated under the terms of the Limited Partnership Agreement. Details are set out in note 3.10.

Distributions from underlying funds are recorded based on the nature of the distribution as provided by the underlying fund's manager which includes realised gains on investments and investment income. Investment income and realised gains is recognised on the value date of the notice received from the underlying fund's manager.

3.4 Financial instruments

The Fund has chosen to adopt the Sections 11 and 12 of FRS 102 in respect of financial instruments.

3. Summary of significant accounting policies (continued)

3.4 Financial instruments (continued)

a) Financial assets

Basic financial assets, including trade and other receivables and cash and bank balances, are initially recognised at transaction price, unless the arrangement constitutes a financing transaction, where the transaction is measured at the present value of the future receipts discounted at a market rate of interest. Such assets are subsequently carried at amortised cost, using the effective interest method.

Other financial assets, such as Fund Investments, are initially measured at fair value, which is normally the transaction price. Such assets are subsequently carried at fair value and the changes in fair value are recognised in profit or loss.

Financial assets are derecognised when (a) the contractual rights to the cash flows from the asset expire or are settled, or (b) substantially all the risks and rewards of the ownership of the asset are transferred to another party, or (c) control of the asset has been transferred to another party who has the practical ability to unilaterally sell the asset to an unrelated third party without imposing additional restrictions.

b) Financial liabilities

Basic financial liabilities, including trade and other payables, are initially recognised at transaction price, unless the arrangement constitutes a financing transaction, where the debt instrument is measured at the present value of the future outflows / payments discounted at a market rate of interest.

These financial liabilities are subsequently carried at amortised cost, using the effective interest method.

Financial liabilities are derecognised when the liability is extinguished, that is when the contractual obligation is discharged, cancelled or expires.

c) Unconsolidated subsidiaries

Subsidiaries are excluded from consolidation whereby they are held as an investment. Subsidiaries held as part of an investment portfolio shall be measured at fair value with changes in fair value recognised in the profit or loss.

3.5 Functional currency

The General Partner considers the Euro as the Fund's functional and presentational currency as it most faithfully represents the economic effects of the underlying transactions, events and conditions.

Unrealised foreign currency exchange gains and losses on non-Euro denominated Investments arising from changes in foreign currency exchange rates and realised foreign exchange gains and losses on income and expenses are included in the Statement of Comprehensive Income. Non-Euro denominated assets and liabilities are translated at the exchange rate at the Statement of Financial Position date. Non-Euro income and expense transactions are translated at the exchange rate prevailing on the date of the transaction.

3.6 Cash and cash equivalents

Cash includes cash in hand and cash with banks. Cash equivalents are short-term, highly liquid investments that are readily convertible to known amounts of cash with original maturities of three months or less and that are subject to an insignificant risk of change in value. At 31 December 2021 and 31 December 2020, there were no cash equivalents.

3.7 Taxation

No provision has been made in the financial statements for taxation of the General Partner and the Limited Partners. All Partners are individually responsible for reporting their share of the Fund's income, gains and losses for taxation purposes.

3.8 Net assets attributable to Partners

The Fund's contributed capital consists of capital and loan contributions. Net assets attributable to Partners is classified as a financial liability, due to the Fund's finite life and contractual payment provisions to each of the Partners.

Notes to the Financial Statements (continued)

3. Summary of significant accounting policies (continued)

3.9 Carried interest liability

The carried interest liability is classified as a financial liability at fair value through profit or loss within the Statement of Financial Position. This liability is calculated based on a hypothetical liquidation of the Fund at the reporting date and represents the estimated share of Net assets attributable to Partners allocable to the Founder Partner, as carried interest, after the repayment of the Limited Partners' outstanding loans and the Preferred Return, in accordance with the distribution provisions of the Limited Partnership Agreement outlined in note 3.10. Please also refer to note 9 to the financial statements for further details on the carried interest liability.

3.10 Distribution of income proceeds and capital proceeds between Partners

The Fund's net income, gains and losses are allocated in accordance with the distribution provisions of the Limited Partnership Agreement. Distributions are allocated pro rata in accordance with each Partner's capital contributions until the Limited Partners have received distributions equalling the sum of:

- (a) Repayment of investors' outstanding loans pro rata to their respective capital contributions; and
- (b) Preferred Return (as defined in the Limited Partnership Agreement) of 8% per annum, compounded annually on 31 December.

In general, subsequent distributions will be allocated 100% to the Founder Partner until the Founder Partner has received aggregate distributions equalling 5% of net profits from Fund Investments and 10% of net profits from Co-investments where applicable.

In the event that the net profits from Fund Investments are positive and net profits from Co-investments are not positive, the amount allocated to the Founder Partner as the catch up amount will equal 5% of the sum of the aggregate net profit.

In the event that net profits from Co-investments are positive and net profits from Fund Investments are not positive, the amount allocated to the Founder Partner as the catch up amount will equal 10% of the aggregate net profit.

All remaining distributions in excess of the catch up amount, described above, will be allocated:

- (a) 5% to the Founder Partner and 95% to all Limited Partners pro rata in accordance with each partner's capital commitments if net profits from Fund Investments are positive and net profits from Co-investments are not positive; 95% to all Limited Partners in proportion to their loan commitments.
- (b) 10% to the Founder Partner and 90% to all Limited Partners pro rata in accordance with each partner's capital commitments if net profits from Co-investments are positive and net profits from Fund Investments are not positive; or
- (c) in all other cases 5% of net profits from Fund Investments to the Founder Partner and 95% to all Limited Partners pro rata in accordance with each partner's capital commitment and 10% of the net profits from Co-investments to the Founder Partner and 90% to all Limited Partners pro rata in accordance with each partner's capital commitment.

During the year, the Fund repaid Limited Partners' outstanding loans, the Preferred Return and carried interest of €11,270,999 (2020: €Nil) to the Founder Partner, based on realised net gains from Investments. In addition, a carried interest liability has been calculated based on a hypothetical liquidation of the Fund at 31 December 2021, which would result in profits of €3,403,564 (2020: €13,816,234) being payable to the Founder Partner. This liability is recognised in the Statement of Financial Position as 'Carried interest liability' and is disclosed in note 9.

4. Critical accounting estimates and judgements

There are key assumptions concerning the future and other key sources of estimation uncertainty at the reporting date, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year. The Fund based its assumptions and estimates on parameters available when the financial statements were prepared. However, existing circumstances and assumptions about future developments may change due to market changes or circumstances arising beyond the control of the Fund. Such changes are reflected in the assumptions when they occur.

4.1 Fair value of investments not quoted in an active market

The Investments of the Fund are valued by the General Partner with reference to the 'International Private Equity and Venture Capital Valuation Guidelines' ('the Guidelines').

Fund Investments are stated at the General Partner's estimate of fair value and follow the recommendations of the Guidelines. The estimate of fair value is based on the latest valuation placed on a fund by its manager, adjusted, if required, for cash flows between the date of the manager's report and the date of the Fund's Statement of Financial Position.

Notes to the Financial Statements (continued)

4. Critical accounting estimates and judgements (continued)

4.1 Fair value of investments not quoted in an active market (continued)

The General Partner reviews the valuations prepared by the managers of Co-investments and determines whether it is appropriate to apply such valuations to the Fund's Co-investments. Where the General Partner does not consider it appropriate to adopt a manager's valuation, it will make its own estimate of fair value in line with the Guidelines.

The General Partner may rely upon any valuations provided to it by the managers of the Fund Investments and Co-investments and apply such valuations to the Investments of the Fund, but shall not be bound by these. The managers' valuations are typically in line with the Guidelines. Where the General Partner does not consider it appropriate to adopt a manager's valuation, it will make its own estimate of fair value in line with the Guidelines. The unrealised and realised gains and losses on Investments are recorded in the Statement of Comprehensive Income.

The Fund allocates management profit share to the General Partner in respect of each accounting period calculated on daily balances equal to:

Management profit share in respect of 'A' commitments:

- 0.085% per annum of total 'A' commitments from years 9 until the termination of the Fund.

Management profit share in respect of 'B' commitments:

- 0.085% per annum of total 'B' commitments committed to Small Fund Investments from years 9 until the termination of the Fund.

The management profit share ranks as the first charge on net income and net realised gains in any accounting period and is paid in full by the Fund whether or not there are sufficient net income and net realised gains to cover the amount. Such sums are not recoverable except against future net income and net realised gains of the Fund.

At 31 December 2021 and 31 December 2020, the total amount of net income and net realised gains exceeded the total amount of management profit share since inception and therefore no part has been paid in advance.

11. Related party transactions

The Limited Partnership Agreement provides that ESP Golden Bear General Partner Limited Partnership shall act as General Partner and is entitled to a management profit share as described in note 10. During the year to 31 December 2021, the General Partner was allocated management profit share of €437,750 (2020: €437,750) and carried interest of €11,270,999 (2020: €Nil). At 31 December 2021, €3,403,564 (2020: €13,816,234) was due to the General Partner in respect of its carried interest liability. The General Partner of ESP Golden Bear General Partner Limited Partnership is SLCP (General Partner ESP Cal) Limited, a wholly owned subsidiary of abrdn CP (Holdings) Limited (formerly known as SLCP (Holdings) Limited), which is a subsidiary of the ultimate parent, abrdn plc. The registered address of abrdn CP (Holdings) Limited and abrdn plc is 1 George Street, Edinburgh, EH2 2LL, United Kingdom.

The Manager of the Fund receives a management fee, equal to the management profit share allocated to the General Partner, in relation to its activity as Manager of the Fund.

abrdn Investment Management Limited (formerly known as Standard Life Investments Limited), a related entity sharing the same ultimate parent with the General Partner, has committed €15,000,000 to the Fund as a Limited Partner. During the year, distributions of €1,336,027 (2020: €881,550) were made to abrdn Investment Management Limited of which €16,511 (2020: €7,831) was temporary return of capital, which is recallable. In addition, €27,670 (2020: €179,126) was contributed by abrdn Investment Management Limited to the Fund during the year.

Certain employees of the Manager are carried interest partners in ESP Golden Bear General Partner Limited Partnership and are entitled to participate in the profits as disclosed in note 3.10.

SL Capital SOF I LP and Pearl Private Equity LP, related entities with the same ultimate parent as the General Partner, have invested €36,015,056 in total via the secondary market to purchase the Limited Partnership Interests in the Fund. As at 31 December 2021, the total effective commitment from the two entities was €69,324,040 (2020: €69,324,040). During the year, distributions totalling €6,174,587 (2020: €4,074,176) were made to these two entities of which €76,308 (2020: €36,194) was temporary return of capital, which is recallable. In addition, €127,879 (2020: €827,850) was further contributed by these entities to the Fund during the year.

Moreover, SL Capital SOF II LP, a related entity with the same ultimate parent as the General Partner has transferred its ownership interest during the year, with effective commitment amounting to €81,743,201. Prior to the transfer, distributions of €2,062,905 (2020: €4,804,050) were made to SL Capital SOF II LP of which €89,979 (2020: €42,678) was temporary return of capital, which is recallable. In addition, €150,788 (2020: €976,157) was contributed by SL Capital SOF II LP to the Fund during the year.

The Fund holds 100% ownership in ESP GB (Funds) S.à r.l. Please see note 14 for full details of the relationship.

At 31 December 2021 €647 (2020: €76,463) was due from the General Partner in respect of expenses paid on its behalf.

12. Risk management

The overall strategy for the management of investment risk is driven by the investment policy as set out in the Limited Partnership Agreement. This is reviewed periodically by the Manager. Investments are selected by the Manager to achieve the investment objective of generating attractive returns, subject to prudent diversification. As a matter of policy there are no pre-set sector allocations, however, risk is spread by investing across a range of countries, industrial sectors and vintage years. The Fund's financial assets are predominately unsecured investments in unquoted companies and limited partnerships, in which the maximum risk is considered to be the amount committed.

12.1 Market risk

a) Price risk

The Fund's investing activities expose it to various types of risk that are associated with the financial instruments and markets in which it invests. The most important types of financial risks to which the Fund is exposed are market risk (including price risk and currency risk), credit risk and liquidity risk. The risk management policies employed by the Fund are detailed below:

The Fund is at risk of the economic cycle impacting the quoted markets and hence potentially the pricing of investment deals, the valuation of underlying investments and the price and timing of exits.

Notes to the Financial Statements (continued)

12. Risk management (continued)

12.1 Market risk (continued)

a) Price risk (continued)

The valuation methodology employed by the managers of funds may include the application of ratios derived from listed companies with similar characteristics. If any investments become quoted, they will be valued at the appropriate listed price, subject to any discount for marketability restrictions. Therefore, the value of the Fund's portfolio may be indirectly affected by price movements on listed exchanges.

Price risk is minimised by the Manager constructing a diversified portfolio of Fund Investments and Co-investments. At 31 December 2021, there were 16 Fund Investments (2020: 20). In addition, the Fund has fully realised its Co-investments. More detail on the sector and geographic analysis is provided in the Manager's Report, which is issued separately.

A 10% increase in the 31 December 2021 valuation of the Fund's Investments would have increased net assets attributable to Partners by €6,214,936 (2020: €10,076,543); a 10% change in the opposite direction would have decreased net assets attributable to Partners by €6,214,937 (2020: €10,076,543).

b) Currency risk

The Fund's commitments to its Investments are made in currencies other than Euro and accordingly a proportion of its net assets are in currencies other than Euro. As a result, the Fund's Statement of Financial Position is sensitive to movements in foreign exchange rates. The Fund has not hedged its foreign currency exposure, however, any cash received in a currency other than Euro is converted into Euro to minimise the exposure to fluctuations in exchange rates.

12.2 Credit risk

Credit risk is the exposure to loss arising from the failure of a counterparty to deliver securities or cash for acquisitions or disposals of investments or to repay deposits.

The maximum exposure to credit risk, in the event that counterparties fail to perform their obligations as at the period end (in relation to each class of recognised financial assets), is the carrying amount of those assets in the Statement of Financial Position.

The Fund places cash with authorised deposit takers and, therefore, is potentially at risk from the failure of any such institution. At 31 December 2021, all of the Fund's cash was held by Societe Generale which was rated "A" by Standard & Poor's at the date of the Report of the General Partner.

At 31 December 2021, the assets held by the Fund are not past due or impaired (2020: €Nil).

12.3 Liquidity risk

The Fund's Investments are in unquoted fund investments and companies which are not traded in a regulated public market and are generally illiquid. As a result, the Fund may not be able to quickly liquidate these portfolio Investments at an amount equal to their fair value, in order to meet its liquidity requirements. The Manager mitigates this risk by regularly monitoring its cash position to ensure sufficient funds exist to meet liabilities as they fall due.

During the year ended 31 December 2021 the Fund generated an operating profit of €16,218,378 (2020: €6,013,687) of which €10,340,837 (2020: €16,079,000 unrealised losses) was unrealised gains on investments. Cash resources at the end of the year amounted to €2,289,350 (2020: €5,979,683). The liabilities of the Fund are due on demand and within one year. At 31 December 2021, the Fund had outstanding commitments to investments of €9,299,398 (2020: €16,402,337) and had available to it undrawn commitments of €73,849,606 (2020: €74,232,721) from its Limited Partners, which are also due on demand. Based on a hypothetical liquidation of the Fund at 31 December 2021, carried interest of €3,403,564 (2020: €13,816,234) would be payable to the Founder Partner.

12.4 Capital risk management

The capital of the Fund is represented by the net assets attributable to Partners. The Fund's objective when managing the capital is to safeguard the ability to continue as a going concern in order to provide returns for Limited Partners and benefits for other stakeholders and to maintain a strong capital base to support the development of the investment activities of the Fund. In order to maintain or adjust the capital structure the General Partner may call unfunded commitments from the Limited Partners or distribute funds to the Limited Partners.

The General Partner monitors capital on the basis of the value of net assets attributable to Partners.

13. Financial assets at fair value through profit or loss

FRS 102 requires a three-level hierarchy disclosure for categorising financial assets and liabilities carried at fair value and requires enhanced disclosures about fair value measurement. The fair value hierarchy classifies financial assets and liabilities according to the source of inputs ranked according to availability of observable market prices used in measuring fair value as follows:

The determination of what constitutes "observable" requires significant estimation by the General Partner. The General Partner considers observable data to be market data which is readily available, regularly distributed or updated, reliable and verifiable, not proprietary and provided by multiple, independent sources that are actively involved in the relevant market.

The Fund has an investment in an unconsolidated subsidiary at fair value through profit or loss. At 31 December 2021, the unconsolidated subsidiary had a carrying value of €7,392,524 (2020: €7,853,947). The unconsolidated subsidiary was formed to act as a holding company for a Fund Investment. The carrying value of this investment has been determined based on net asset value techniques. Distributions of €3,370,380 from the unconsolidated subsidiary was received during the year ended 31 December 2021 (2020: €4,752,125). The proceeds comprise return of cost, gains, and income of €1,824,820 (2020: €1,351,173), €1,461,335 (2020: €3,061,801), and €84,225 (2020: €339,151), respectively. In addition, €68,750 was contributed by the Fund during the year (2020: €691,073).

The Fund has committed €12,500,000 to this investment, through the unconsolidated subsidiary, of which €868,750 (2020: €937,500) remains outstanding. The Fund makes contributions to the unconsolidated subsidiary on demand and bears 100% of the costs attributable to it.

Movements in the fair value of the subsidiary may expose the Fund to a gain / loss.

15. Events after the reporting date

Subsequent events have been evaluated up to 1 July 2022.

The Fund made a permanent distribution to the Limited Partners of €17,255,129 after the reporting date.

As at the date of the approval of the financial statements the Fund's did not hold any assets in Ukraine or Russia. The Fund's key suppliers do not have operations pertaining to the Fund's in Ukraine or Russia.

This includes but is not limited to ensuring that the requirements of all international sanctions are adhered to, managing the assets of the Fund proactively to best mitigate risk and ensuring that the Investment Manager and other key suppliers continue to operate all protections, protocols and monitoring of heightened cyber threats. At the time of writing, there is not expected to be any significant long term adverse direct impact from the conflict in Ukraine on the assets, processes and procedures of the Fund.

The General Partner has identified no other significant events after the reporting date.

Report of the General Partner

The General Partner, SLCP (General Partner ESP Cal) Limited, presents the audited financial statements for ESP Golden Bear General Partner Limited Partnership ("the Partnership") for the year ended 31 December 2021.

Structure of the Partnership

The Partnership was formed on 29 August 2007 and is registered in Scotland, United Kingdom ("U.K.").

Directors of the General Partner

Please refer to the financial statements of SLCP (General Partner ESP Cal) Limited for the names of the Directors. Ian Harris resigned as Director on 1 October 2021. Stewart Hay and Roger Pim resigned on 22 February 2022.

Distributions

Distributions of €11,708,749 (2020: €437,750) were made during the year.

COVID-19

The General Partner, as part of the abrdn plc group (formerly known as Standard Life Aberdeen plc group), is continuing to utilise business continuity and resilience processes with the objective of mitigating the impact of COVID-19. Please refer to note 3.2 for the General Partner's assessment of the Partnership's ability to continue as a going concern.

Events after the reporting date

At the date of this report, ESP Golden Bear has extended the date of expiration to 10 August 2023, with one further remaining extension available per the Limited Partnership Agreement. Under the terms of the Limited Partnership Agreement, the Qualifying Partnership, as General Partner of ESP Golden Bear, can extend the life per the extension powers granted to them for an additional year. The General Partner has the intention to use the additional one year extension which will extend the life of ESP Golden Bear to 10 August 2024. Thus the date of the termination of the Qualifying Partnership will be on 8 November 2024, which is 90 days after the expiry date of the underlying fund.

There has not been any permanent distribution made to the Limited Partners after the reporting date.

Post the year-end date, on 24th February 2022, Russia launched a military offensive in Ukraine resulting in widespread sanctions on Russia and heightened security and cyber threats.

The situation in the region is rapidly evolving and the General Partner and the Manager continue to monitor the situation carefully and will take whatever steps are necessary and in the best interests of the Partnership's Investors. This includes but is not limited to ensuring that the requirements of all international sanctions are adhered to, managing the assets of the Partnership proactively to best mitigate risk and ensuring that the Manager and other key suppliers continue to operate all protections, protocols and monitoring of heightened cyber threats. At the time of writing, there is not expected to be any significant long term adverse direct impact from the conflict in Ukraine on the assets, operational activities, processes and procedures of the Partnership.

As at the date of the approval of the financial statements, the Partnership did not hold any assets in Ukraine or Russia. The Partnership's key supplier do not have operations pertaining to the Partnership in Ukraine or Russia.

There are no other significant events identified after the reporting date.

Results, activities and future developments

The results for the year are set out in the Statement of Comprehensive Income on page 8. A description of the principal activity of the Partnership is provided in note 1 to the financial statements.

The principal activity of the Partnership is to act as General Partner to ESP Golden Bear Europe Fund ("ESP Golden Bear").

Going concern basis

Notwithstanding net current liabilities of €105,269 at 31 December 2021, the Partnership, along with the ongoing financial support of abrdn Investment Management Limited (formerly Standard Life Investments Limited), a related party, will continue to be in a position to meet liabilities as they fall due for at least twelve months from the date of approval of the financial statements and as such the General Partner deems it appropriate to prepare the financial statements of the Partnership on the going concern basis. The General Partner acknowledges that there can be no certainty that this support will continue, although, as at the date of approval of these financial statements, has no reason to believe that it will not do so.

Going concern basis (continued)

ESP Golden Bear has extended the date of expiration to 10 August 2023. The General Partner has the intention to use the remaining one year extension which will extend the life of ESP Golden Bear to 10 August 2024. Thus the date of the termination of the Qualifying Partnership will be on 8 November 2024, which is 90 days after the expiry date of the underlying fund.

Disclosure of information to auditor

At the date of this report, the General Partner confirms that:

- As far as the General Partner is aware, there is no relevant information of which the Partnership's auditor is unaware; and
- The General Partner has taken all the steps that it ought to have taken as a General Partner in order to make it aware of any relevant audit information and to establish that the Partnership's auditor is aware of that information.

- have been properly prepared in accordance with U.K. accounting standards, including FRS 102 The Financial Reporting Standard applicable in the U.K. and Republic of Ireland; and

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (U.K.) ("ISAs (U.K.)") and applicable law. Our responsibilities are described below. We have fulfilled our ethical responsibilities under, and are independent of the Qualifying Partnership in accordance with, U.K. ethical requirements including the FRC Ethical Standard. We believe that the audit evidence we have obtained is a sufficient and appropriate basis for our opinion.

Going concern

The General Partner has prepared the financial statements on the going concern basis as they do not intend to liquidate the Qualifying Partnership or to cease its operations, and as they have concluded that the Qualifying Partnership's financial position means that this is realistic. They have also concluded that there are no material uncertainties that could have cast significant doubt over its ability to continue as a going concern for at least a year from the date of approval of the financial statements ("the going concern period").

In our evaluation of the General Partner's conclusions, we considered the inherent risks to the Qualifying Partnership's business model and analysed how those risks might affect the Qualifying Partnership's financial resources or ability to continue operations over the going concern period.

Our conclusions based on this work:

- we consider that the General Partner's use of the going concern basis of accounting in the preparation of the financial statements is appropriate; and
- we have not identified and concur with the General Partner's assessment that there is not, a material uncertainty related to events or conditions that, individually or collectively, may cast significant doubt on the Qualifying Partnership's ability to continue as a going concern for the going concern period.

However, as we cannot predict all future events or conditions and as subsequent events may result in outcomes that are inconsistent with judgements that were reasonable at the time they were made, the above conclusions are not a guarantee that the Qualifying Partnership will continue in operation.

Fraud and breaches of laws and regulations – ability to detect

Identifying and responding to risks of material misstatement due to fraud

To identify risks of material misstatement due to fraud ("fraud risks") we assessed events or conditions that could indicate an incentive or pressure to commit fraud or provide an opportunity to commit fraud. Our risk assessment procedures included:

- reading minutes of meetings of those charged with governance.

As required by auditing standards, and taking into account our overall knowledge of the control environment, we performed procedures to address the risk of management override of controls, in particular the risk that management may be in a position to make inappropriate accounting entries. On this audit we do not believe there is a fraud risk related to revenue recognition because revenue streams are simple in nature with respect to accounting policy choice, and are easily verifiable to external data sources or agreements with little or no requirement for estimation from management. We did not identify any additional fraud risks.

We performed procedures including journal entries and other adjustments to test based on risk criteria and comparing the identified entries to supporting documentation. These included post-closing journals.

Identifying and responding to risks of material misstatement related to compliance with laws and regulations

We identified areas of laws and regulations that could reasonably be expected to have a material effect on the financial statements from our general commercial and sector experience and through discussion with the General Partner (as required by auditing standards), and discussed with the General Partner the policies and procedures regarding compliance with laws and regulations.

The potential effect of these laws and regulations on the financial statements varies considerably.

The Qualifying Partnership is subject to laws and regulations that directly affect the financial statements including financial reporting legislation (including related companies legislation as applied to qualifying partnerships) and we assessed the extent of compliance with these laws and regulations as part of our procedures on the related financial statement items.

Whilst the Qualifying Partnership is subject to many other laws and regulations, we did not identify any others where the consequences of non-compliance alone could have a material effect on amounts or disclosures in the financial statements.

Notes to the Financial Statements

1. Partnership background

The Partnership was formed for the purpose of acting as the General Partner of ESP Golden Bear. The Partnership is registered in Scotland, U.K. and was established on 29 August 2007 with combined commitments of €100 from its Carried Interest Partners. The combined commitments of the Carried Interest Partners were adjusted to €57 following the final close of ESP Golden Bear. The Manager of the Partnership is abrdn Capital Partners LLP, which is authorised and regulated by the Financial Conduct Authority and is a U.S. Securities and Exchange Commission registered investment advisor based in Edinburgh, U.K.

The Partnership shall continue until the expiry of 90 days after the termination of ESP Golden Bear which is expected to terminate ten years after investment period. The Partnership has no employees.

2. Statement of compliance

The financial statements of the Partnership have been prepared in compliance with United Kingdom Accounting Standards, including FRS 102, the Companies Act 2006 and the Regulations.

3. Summary of significant accounting policies

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

3.1 Basis of preparation

These financial statements are prepared on a going concern basis, under the historical cost convention, as modified by the recognition of certain financial assets and liabilities measured at fair value through profit or loss. The financial statements are presented in Euro ("€"), which is also the Partnership's functional currency.

3.2 Going concern

The financial statements have been prepared under the historical cost convention in accordance with the Companies Act 2006, and under the going concern principle on the basis that the Partnership has sufficient resources from its parent undertaking should it require to meet its liabilities.

The Partnership has net current liabilities and is therefore reliant on support from abrdn Investment Management Limited to meet its liabilities as they fall due within the next 12 months. The General Partner has received a letter of support from the directors of abrdn Investment Management Limited to continue to provide further financial and other support to the Partnership for at least the next 12 months.

As with any entity placing reliance on other group entities for financial support, the General Partner acknowledges that there can be no certainty that this support will continue although, at the date of approval of these financial statements, they have no reason to believe that it will not do so.

Based on a review of the above factors, the General Partner is satisfied that the Partnership has sufficient liquidity to withstand the potential downside scenarios as a result of COVID-19. Consequently the General Partner is satisfied that the Partnership has and will maintain sufficient resources to continue to meet its liabilities as they fall due for at least 12 months from the date of approval of the financial statements. Accordingly, the financial statements have been prepared on a going concern basis.

The current extension of ESP Golden Bear will expire on 10 August 2023, with one further extension remaining per the Limited Partnership Agreement. Under the terms of the Limited Partnership Agreement, the Qualifying Partnership, as General Partner of ESP Golden Bear, can extend the life per the extension powers granted to them for an additional year. The General Partner has the intention to use the additional one year extension which will extend the life of ESP Golden Bear to 10 August 2024. Thus the date of the termination of the Qualifying Partnership will be on 8 November 2024, which is 90 days after the expiry date of the underlying fund.

3. Summary of significant accounting policies (continued)

3.3 Income, expenses, gains and losses

All income and expenses, inclusive of realised gains and losses, are accounted for on an accrual basis in the Statement of Comprehensive Income. This includes amounts arising in ESP Golden Bear which have been allocated to the Partnership's account in ESP Golden Bear.

Management profit share is received from ESP Golden Bear as the first charge on net income and net realised gains in any accounting period whether or not there are sufficient net income and net realised gains in that accounting period. The full management profit share received by the Partnership from ESP Golden Bear is included in the Statement of Comprehensive Income.

The Partnership is entitled to receive carried interest from ESP Golden Bear if specific performance criteria within ESP Golden Bear are met. In accordance with FRS 102, the Partnership recognises revenue at the fair value of consideration received or receivable when the amount can be measured reliably and it is probable that the economic benefits associated with the transaction will flow to the entity. Carried interest amounts are therefore recognised as revenue at or close to the point that the preferred return hurdle in ESP Golden Bear has been exceeded, taking into account the current valuation of ESP Golden Bear's investments, future estimated cash flows over the remaining life of ESP Golden Bear and any potential clawback.

Consideration of whether the criteria to recognise carried interest has been met is considered at note 4.2.

3.4 Financial instruments

a) Financial assets

Basic financial assets, including trade and other receivables and cash and bank balances, are initially recognised at transaction price, unless the arrangement constitutes a financing transaction, where the transaction is measured at the present value of the future receipts discounted at a market rate of interest. Such assets are subsequently carried at amortised cost, using the effective interest method.

Other financial assets, such as Investments, are initially measured at fair value, which is normally the transaction price. Such assets are subsequently carried at fair value and the changes in fair value are recognised in the Statement of Comprehensive Income.

Financial assets are derecognised when (a) the contractual rights to the cash flows from the asset expire or are settled, or (b) substantially all the risks and rewards of the ownership of the asset are transferred to another party or (c) control of the asset has been transferred to another party who has the practical ability to unilaterally sell the asset to an unrelated third party without imposing additional restrictions.

b) Financial liabilities

Basic financial liabilities, including trade and other payables are initially recognised at transaction price, unless the arrangement constitutes a financing transaction, where the debt instrument is measured at the present value of the future payments discounted at a market rate of interest.

These financial liabilities are subsequently carried at amortised cost, using the effective interest method.

Financial liabilities are derecognised when the liability is extinguished, that is when the contractual obligation is discharged, cancelled or expires.

3.5 Functional currency

The General Partner considers the Euro as the Partnership's functional and presentational currency as it most faithfully represents the economic effects of the underlying transactions, events and conditions.

Non-Euro denominated assets and liabilities are translated at the exchange rate at the date of the Statement of Financial Position. Non-Euro income and expense transactions are translated at the exchange rate prevailing on the date of the transaction.

3.6 Cash and cash equivalents

Cash includes cash in hand and cash with banks. Cash equivalents are short-term, highly liquid investments that are readily convertible to known amounts of cash with original maturities of three months or less and that are subject to an insignificant risk of change in value. At 31 December 2021 and 31 December 2020, there were no cash equivalents.

3.7 Taxation

No provision has been made in the financial statements for taxation of the Partners. All Partners are individually responsible for reporting their share of the Partnership's income, gains and losses for taxation purposes.

4. Critical accounting estimates and judgements

There are key assumptions concerning the future and other key sources of estimation uncertainty at the reporting date, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year. The Partnership based its assumptions and estimates on parameters available when the financial statements were prepared. However, existing circumstances and assumptions about future developments may change due to market changes or circumstances arising beyond the control of the Partnership. Such changes are reflected in the assumptions when they occur.

4.1 Fair value of investments not quoted in an active market

The Investments in ESP Golden Bear are currently stated at fair value as estimated by the General Partner. The General Partner considers the balance of the Partnership's capital accounts in ESP Golden Bear as being equal to fair value.

4.2 Carried Interest Income

Critical Judgement

Treatment of Carried Interest as Revenue - The treatment of carried interest receivable by the Partnership as revenue from a contract is a critical judgement. Carried interest is payable by ESP Golden Bear when returns on investments exceed specific performance hurdles. The Partnership is the intermediary through which services are provided to ESP Golden Bear, including the appointment of a manager of the assets. Carried interest is therefore judged to be consideration in respect of the provision of these services by the Partnership under a service relationship, rather than a return on an investment interest in ESP Golden Bear.

Critical Estimate

Measurement of Carried Interest Receivable - The measurement of carried interest receivable by the Partnership involves a significant amount of estimation. Revenue is recognised at the fair value of consideration to be received, taking into account the timing and amount of expected future cash flows. Additionally, revenue is only recognised when the amount can be measured reliably and it is probable that the economic benefits associated with the transaction will flow to the entity. Please refer to note 3.3 for further details on the accounting policy for the timing of revenue recognition for the carried interest income recognised during the year ended 31 December 2021 of €11,270,999 (2020: €Nil).

5. Financial assets at fair value through profit or loss

FRS 102 requires a three-level hierarchy disclosure for categorising financial assets and liabilities carried at fair value and requires enhanced disclosures about fair value measurement. The fair value hierarchy classifies financial assets and liabilities according to the source of inputs ranked according to availability of observable market prices used in measuring fair value as follows:

- Level 1** The unadjusted quoted price in an active market for identical assets or liabilities that the entity can access at the measurement date.
- Level 2** Inputs other than quoted prices included within Level 1 that are observable (i.e. developed using market data) for the asset or liability, either directly or indirectly.
- Level 3** Inputs are unobservable (i.e. for which market data is unavailable) for the asset or liability.

The level in the fair value hierarchy within which the fair value measurement is categorised in its entirety should be determined on the basis of the lowest level input that is significant to the fair value measurement in its entirety.

The categorisation of an Investment within the hierarchy is based upon the pricing transparency of that Investment. All of the Partnership's Investments have been classified within Level 3 as they have unobservable inputs and trade infrequently or not at all.

The determination of what constitutes "observable" requires significant estimation by the General Partner. The General Partner considers observable data to be market data which is readily available, regularly distributed or updated, reliable and verifiable, not proprietary and provided by multiple, independent sources that are actively involved in the relevant market.

8. Audit fees

Audit fees incurred by the Partnership amounting to €8,933 (2020: €8,798, of which €419 relates to 2019 audit) are presented under 'Administration and other expenses' in the Statement of Comprehensive Income.

9. Allocation of the Partnership's net income, gains and losses

The Partnership's net income, gains and losses are allocated in accordance with the distribution provisions of the Limited Partnership Agreement dated 18 November 2011. The split between the General Partner and Carried Interest Partners are in accordance with the allocation provisions of the Limited Partnership Agreement. Amounts received by the Partnership in respect of management profit share from ESP Golden Bear are allocated to the General Partner. Amounts received in respect of the Partnership's capital commitment to ESP Golden Bear are allocated to the Carried Interest Partners in proportion to their capital contributions.

At 31 December 2021, amounts of €11,270,999 (2020: €Nil) in respect of carried interest had been received.

10. Related party transactions

The Limited Partnership Agreement provides that SLCP (General Partner ESP Cal) Limited shall act as General Partner and be entitled to distributions equal to amounts received by the Partnership from ESP Golden Bear in respect of management profit share. During the year to 31 December 2021, €437,750 (2020: €437,750) was received by the Partnership from ESP Golden Bear in relation to management profit share and €437,750 (2020: €437,750) was paid to the General Partner in relation to management profit share. SLCP (General Partner ESP Cal) Limited is a wholly owned subsidiary of abrdn CP (Holdings) Limited (formerly known as SLCP (Holdings) Limited), which is a subsidiary of the ultimate parent, abrdn plc. The registered address of abrdn CP (Holdings) Limited and abrdn plc is 1 George Street, Edinburgh, EH2 2LL, United Kingdom.

The Manager of the Partnership receives a management fee, equal to the management profit share allocated to the General Partner, in relation to its activity as the Manager of ESP Golden Bear.

Certain members and employees of the Manager and the discretionary trusts of their families are Carried Interest Partners in the Partnership and are entitled to participate in the profits as disclosed in note 7.

At 31 December 2021, the Partnership owed €43 (2020: €43) to the Carried Interest Partners in respect of capital contribution. At 31 December 2021, the Partnership owed €12 (2020: €12) to the General Partner in respect of initial capital contribution.

At 31 December 2021, the Partnership owed €647 (2020: €76,463) to ESP Golden Bear in respect of expenses paid on its behalf.

11. Risk management

The activities of the Partnership expose it to various types of risks. These risks are mainly associated with the underlying interest that the Partnership has in ESP Golden Bear. The most important type of risks to which ESP Golden Bear is exposed are market risk, currency risk, credit risk and liquidity risk. The financial statements of ESP Golden Bear contain detailed information on the most important risks faced by ESP Golden Bear.

11.1 Market risk

Due to the current stage of ESP Golden Bear, the Partnership's investment in ESP Golden Bear does not yet include any allocation of realised or unrealised gains on the underlying investments. Consequently, the Partnership's Statement of Financial Position at 31 December 2021 is not sensitive to valuation movements that occur in the underlying investments in ESP Golden Bear. The returns of the Partnership in future periods may be affected by such valuation changes.

11.2 Currency risk

ESP Golden Bear is denominated in Euro and has investments denominated in other currencies. Future returns for the Partnership may be affected by changes in currency rates. However, the Partnership's Statement of Financial Position as at 31 December 2021 is not sensitive to movements in foreign exchange rates.

11.3 Credit risk

Credit risk is the exposure to loss arising from the failure of a counterparty to deliver securities or cash for acquisition or disposal of investments or to repay deposits. The Partnership places cash with authorised deposit takers and, therefore, is potentially at risk from the failure of any such institution. At 31 December 2021, all of the Partnership's cash was held by Societe Generale which was rated 'A' by Standard & Poor's at the date of the Report of the General Partner.

11.4 Liquidity risk

The Partnership's investment in ESP Golden Bear is an unquoted Limited Partnership interest. This is generally illiquid and cannot be traded in a regulated public market. As a result, this investment may not be able to be disposed in order to meet the Partnership's liquidity requirements. The Partners' commitments are fully drawn and it is not expected that the Partnership will have any significant cash requirements in the future.

During the year ended 31 December 2021, the Partnership generated a profit attributable to Partners of €11,692,209 (2020: €421,670). Cash resources at the end of the year amounted to €10 (2020: €8). The net current liabilities of the Partnership amounting to €105,269 (2020: €88,729) are due on demand.

11.5 Operational risk

Operational risk is the potential for loss caused by a deficiency in information, communications, investment due diligence process and accounting systems. The Manager and its service providers maintain controls and procedures for the purpose of mitigating operational risks.

11.6 Legal, tax and regulatory risk

Legal, tax and regulatory changes could occur during the term of the Partnership which may have an adverse effect on its assets or returns. The Manager engages external professional advisors in order to mitigate legal, tax and regulatory risks.

12. Commitments and contingencies

The Partnership has committed an aggregate of €57 (2020: €57) to ESP Golden Bear as a carried interest partner with no unfunded commitment as of 31 December 2021.

13. Related undertakings

The Partnership's investment in ESP Golden Bear is classified as subsidiary undertaking as discussed in note 3.1. The Partnership has an indirect holding in Intera Fund II KY through ESP GB (Funds) S.a.r.l. The following table below summarises the Partnership's related undertakings:

14. Events after the reporting date

Subsequent events have been evaluated up to 15 December 2022.

The General Partner has the intention to use the additional one year extension which will extend the life of ESP Golden Bear to 10 August 2024.

There has not been any permanent distribution made to the Limited Partners after the reporting date.

Post the year-end date, on 24th February 2022, Russia launched a military offensive in Ukraine resulting in widespread sanctions on Russia and heightened security and cyber threats.

The situation in the region is rapidly evolving and the General Partner and the Manager continue to monitor the situation carefully and will take whatever steps are necessary and in the best interests of the Partnership's Investors. This includes but is not limited to ensuring that the requirements of all international sanctions are adhered to, managing the assets of the Partnership proactively to best mitigate risk and ensuring that the Manager and other key suppliers continue to operate all protections, protocols and monitoring of heightened cyber threats. At the time of writing, there is not expected to be any significant long term adverse direct impact from the conflict in Ukraine on the assets, operational activities, processes and procedures of the Partnership.

As at the date of the approval of the financial statements, the Partnership did not hold any assets in Ukraine or Russia. The Partnership's key supplier do not have operations pertaining to the Partnership in Ukraine or Russia.

There are no other significant events identified after the reporting date.
