The Sheriff, having considered the foregoing petition, Appoints a copy thereof and of this deliverance to be intimated on the walls of the Sheriff Court at Dunfermline and a like copy to be served upon the said Airsoft World Ltd a company incorporated under the Companies Acts, and having its registered office at 4 Main Street Crossgates, COWDENBEATH, KY4 8AJ; further, Appoints notice of the import of the petition and of this deliverance, and of the particulars specified in the Act of Sederunt to be advertised once in the Edinburgh Gazette and once in the Dunfermline Press newspaper; Ordains the said Airsoft World Ltd a company incorporated under the Companies Acts, and having its registered office at 4 Main Street Crossgates, COWDENBEATH, KY4 8AJ and any other persons interested, if they intend to show cause why the prayer of the petition should not be granted, to lodge answers thereto in the hands of the sheriff clerk at Dunfermline within eight days after such intimation, service or advertisement, under certification; meantime, being satisfied that the share capital of Airsoft World Limited does not exceed £120,000 sterling.
