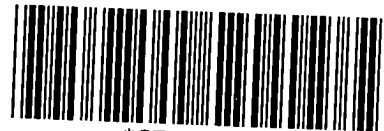

The company is dormant and has not traded during the year.


