The Sheriff, having resumed consideration of the foregoing petition together with the productions produced, and having seen the Edinburgh Gazette dated between 31 August 2022 and 4 September 2022 and the Metro newspaper dated 2 September 2022 each containing the intimation ordered by the preceding interlocutor, no answers to said petition having been lodged in court, Finds (1) that the amount of the share capital of the said Lamellar Biomedical Limited paid up or credited as paid up does not exceed £120,000; (2) that the said company is unable to pay its debts; (3) that the said company has by special resolution resolved that the company be wound up by the court;

therefore Orders that the said company, having its registered office at Level 2, Suites 1 & 2 2 Parklands Way, Eurocentral, Holytown, ML1 4WR be wound up in pursuance of the Insolvency Act, 1986; Nominates and Appoints Ms Julie Tait and Mr Stuart Preston, Insolvency Practitioners, Grant Thornton LLP, 7 Exchange Crescent, Conference Square, Edinburgh EH3 8AN to be the interim liquidators of the said company with the usual powers, all in terms of said Statute and of Law; Finds the petitioner entitled to the expenses of this application and Directs same to be expenses in the liquidation.
