The director presents his report and accounts for the year ended 30th. June 2008.

Accounts and dividend.

The company traded at a profit of £18,319.84 for the year. A dividend on the Ordinary Shares has been proposed and paid for the year.

Principal activities and review of business developments.

The company's principal activity is the provision of structural engineering design services. No significant development is envisaged by the director other than expanding this core activity.

Directors and their interests.

The director, who has served since 1 July 2007, is Mr. Graham Farr. According to the register maintained as required under the Companies Act 1985, the director's beneficial interests in the share capital of the company was 100 Ordinary shares of £1 each.
