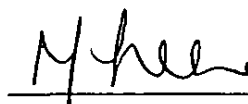

1. FINAL OUTCOME

My final Receipts and Payments Statement, as Liquidator, is attached to this report.

I can confirm that a dividend was paid to ordinary creditors.

2. ASSET REALISATIONS

All assets have been realised in the Liquidation and I can advise that the sum of £91,008 was ingathered in respect of fixtures and fittings, cash at bank and a rates refund.

All asset realisations have been concluded in the Liquidation.

3. PREFERENTIAL CLAIMS

No preferential claims have been received in the Liquidation.

4. FLOATING CHARGE CLAIM

The floating charge was fully satisfied prior to my appointment.

5. ORDINARY CLAIMS

I can confirm that all claims were adjudicated upon and the ordinary claims admitted, amounted to £714,471. A dividend of 2.93p in £ was paid to ordinary creditors.

5. LIQUIDATORS INVESTIGATIONS

An investigation was carried out into the pre appointment activity of the directors of the company and in particular the circumstances surrounding the insolvency of the company. I have sent an appropriate report to the Insolvency Services regarding the director's conduct in terms of the Company Directors Disqualification Act 1986.
