2 no Fixed Security, other than any Fixed Security in favour of the Creditor, and no other floating charge shall rank in priority or preference prior to or equally with the Floating Charge.

Negative Pledge:

Without prejudice to the Ranking provisions above, until the Secured Liabilities have been irrevocably and unconditionally repaid and discharged in full, the Company shall not, without the consent in writing of the Creditor, create or attempt to create or permit to subsist any Security Interest in, over or in any way affecting any of the Secured Property.
