4.1 My receipts and payments account for the period from 19 June 2021 to date is attached at Appendix A and this also incorporates my receipts and payments for the full period of the liquidation.

# 5. WORK UNDERTAKEN INCLUDING REALISATIONS OF ASSETS

#### **Asset Realisations**

Cash at Bank

5.1 £212,928.17 was recovered from the company's bank account.

Corporation Tax Refund

5.2 A small balance of £13.19 was received from HMRC in relation to a Corporation Tax refund due to the company.

Interest received

5.3 Funds were held in an interest-bearing bank account and a nominal sum of £4.13 interest has been received on the funds during the course of the liquidation.

#### Costs incurred

- 5.4 Costs were as follows.
  - (i) £255.00 was paid in respect of the Specific Bond.
  - (ii) Accountancy fees of £2,000 were paid.
  - (iii) £266.58 was in respect of placing statutory notices.
- 5.5 My remuneration is explained in further detail at section 6 below.
- 5.6 VAT was recoverable on costs incurred as the company was previously registered for VAT.

#### **General Administration and Investigation**

- 5.7 During the course of the liquidation I am obliged to document any decisions that affect the case, to maintain records to demonstrate how the liquidation has been administered and undertake regular reviews to ensure that matters are progressed timeously and that the case remains adequately bonded. I am also required to comply with insolvency legislation and best practice in carrying out my duties, including requirements for reporting to the company's members. I am also required to ensure all taxation matters are up to date and to seek clearance to close the liquidation from H M Revenue & Customs.
- 5.8 Whilst this work has no direct financial benefit to the members it has to be undertaken.

#### 6. LIQUIDATOR'S COSTS AND REMUNERATION CHARGED

- 6.1 My remuneration was agreed at the outset of the liquidation on a fixed fee basis set at £2,000.00 and further approval was given by the company's members for me to draw this sum.
- 6.2 Additional time costs were incurred over and above this balance due to the requirement to liaise with HMRC in relation to an issue with a refund owed to the company which never materialised. It was agreed that the small balance of £13.19 received from HMRC in relation to the Corporation Tax refund due would be applied to these costs. This balance has now been drawn.

#### 7. OUTCOME FOR MEMBERS

- 7.1 A first distribution totalling £205,000, at a rate of £2,050 per share, was paid to the shareholder on 1 August 2018.
- 7.2 A second and final distribution of £5,024.81 at a rate of £52.05 per share, was paid to the shareholder on 27 February 2019.
- 7.3 On 6 April 2019, The Insolvency (Scotland) (Receivership and Winding Up) Rules 2018 ("the Rules") replaced those parts of the Insolvency (Scotland) Rules 1986 that applied to Liquidations. As a result, there is no longer a requirement to call and advertise a final meeting in Members Voluntary Liquidations. Accordingly, the sum of £91.91 which had been retained to cover the final advertising costs was forwarded to the shareholder on 1 July 2019.

#### 8. OTHER MATTERS / CONCLUSION OF LIQUIDATION

8.1 As above this report is my final account to members and a Notice in this regard accompanies the Report. I will be granted my release and vacate office on filing my final account with the Registrar of Companies and Accountant in Bankruptcy.
