

1. Introduction

As you are aware, I was appointed Interim Liquidator of the Company by Interlocutor of the Sheriff at Airdrie Sheriff Court on 1 October 2014 following the presentation of a petition by HM Revenue & Customs ("HMRC") on 22 August 2014.

I was appointed Liquidator at the Meeting of Creditors on 18 November 2014.

4. Action taken by the Liquidator

Assets

No assets were realised in the period of this Report.

5. Liabilities and Dividends

Preferential Creditors

No claims have been received.

Floating Charge Creditors

The Company granted two Floating Charges to Bank of Scotland plc ("the Bank") which were created on 24 December 2014 and 16 January 2015 and registered on 9 January 2015 and 22 January 2015 respectively. No claim has been received from the Bank.

Section 176A of the Insolvency Act 1986 requires the Liquidator to set aside a prescribed amount of the Company's "net property" towards the satisfaction of unsecured debts. Net property is the amount of property that would otherwise be available for satisfaction of holders of any Floating Charge created by the Company after 15 September 2003. The prescribed part applies.

Unsecured Creditors

As advised in my previous report a dividend of 2.66p in the £ was paid to the Ordinary creditors, however, was paid out with the period. The dividend payments now show on the receipts and payments attached at **Appendix II.**

6. Liquidator's Remuneration, Disbursements and Expenses

Attached at **Appendix III** is a SIP 9 schedule which summaries the time costs accrued in the period 22 August 2022 to 14 October 2022. This shows time costs of £708.00, a total of 3.50 hours at an average rate of £202.29 per hour.

As my final fee has been approved and drawn in the Liquidation, there will be no further fees taken.
