~~The Lord Ordinary, having considered the petition, no caveat having been lodged,~~

- (1) appoints the petition to be intimated on the Walls of Court in common form and appoints the petition to be advertised once in the Edinburgh Gazette and The Scotsman newspaper;
- (2) appoints any party claiming an interest to lodge answers thereto within eight days after such intimation and advertisement;
