



The company curated and produced an exhibition of work by international and European silversmiths who are Members of the HammerClub. The members visited Scotland for the first time and the exhibition was part of this gathering with demonstrations and presentations.

The company has continued to provide services for Applied Arts Scotland, a SCIO run by makers for makers to support the making community in Scotland. Rio provides support by developing and writing content for their website, email newsletters, PR and administrative support.

Both of these activities benefited makers in Scotland and the exhibition promoted silversmithing to wider audiences.
