The sheriff, having resumed consideration of the foregoing petition together with the productions produced, and having seen the Edinburgh Gazette dated 24 December 2021 and the Metro newspaper dated 21 December 2021 each containing the intimation ordered by the preceding interlocutor, no answers to said petition having been lodged in court, Finds (1) that the amount of the share capital of the said William Cumming and Son Ltd, a company incorporated in Scotland under the Companies Acts (company number SC366917) and having its Registered Office at paid up or credited as paid up does not exceed £120,000; (2) that the said company is unable to pay its debts;

therefore Orders that the said company, having its registered office at 10 Alloway Street, Ayr, Ayrshire, Scotland, KA7 1SH be wound up in pursuance of the Insolvency Act, 1986; Nominates and Appoints Blair Carnegie Nimmo, Insolvency Practitioner of Interpath Ltd, 31 Charlotte Square, Edinburgh, EH2 4E and Geoffrey Isaac Jacobs, Insolvency Practitioner of Interpath Ltd, 319 St. Vincent Street, Glasgow, G2 5AS to be the interim liquidators of the said company with the usual powers, all in terms of said Statute and of Law; Finds the petitioner entitled to the expenses of this application and Directs same to be expenses in the liquidation.
