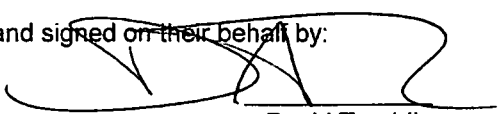
The Board of directors confirm that:
