Hill City CIC continued to operate on a part-time basis. We used our fourth year of operations to continue to assess the suitability and viability of our services and to pilot and run a community project within a local neighbourhood in Scotland. We maintained our client base for web hosting, which provided affordable unlimited web hosting for our clients. In addition, our pilot community project (Hosting Hope) launched successfully, as we hosted free monthly community lunches at Linton Lane Centre in the neighbourhood of Templehall in Kirkcaldy. These lunches not only provided some relief from food poverty and social isolation, it provided a platform for our stakeholders from various churches to be involved in volunteering for a worthwhile community-building initiative.

Hill City's stakeholders are the people who form the congregations of local churches in the United Kingdom. This year, in ongoing personal consultation with our stakeholders, Hill City CIC applied the following actions as a continuation of our intentions from the previous financial year:

- Continued to offer affordable unlimited web hosting as the company's core business, and to make this available also to people and organizations who were not originally our stakeholders.
- 2. Any profit from the provision of web hosting would be used to fund Hosting Hope, our community project which would benefit the local community. With the assistance of local stakeholders, we negotiated a partnership with Linton Lane Centre in Kirkcaldy to allow us preferable use of their premises for our monthly community lunch. Hosting Hope launched in December 2015, and is scheduled to run monthly in 2016. A small team of volunteers from various churches have been assisting in the delivery of these lunches.
- To maximise the viability of Hosting Hope, the decision was made to accept donations (financial and in kind) which would supplement any profit made from the provision of web hosting, and which would add benefit to the actual running of the community lunches.
