The sheriff having resumed consideration of the foregoing Petition together with the productions,

(1) having seen the *Edinburgh Gazette* dated 9 May 2023 and the *Metro* newspaper dated 10 May 2023, and publication on the SCTS Website each containing the intimation ordered by the preceding interlocutor, no Answers to said Petition having been lodged in court;

(2) finds that the amount of the share capital of the said Vert Rotors UK Limited, paid up or credited as paid up does not exceed £120,000, and that the said company is unable to pay its debts;

(3) therefore orders that Vert Rotors UK Limited, having its registered office at Unit A1, Gracemount Business Pavilions, Edinburgh, EH17 8QF be wound up in pursuance of the Insolvency Act, 1986;

(4) nominates and appoints Richard Gardiner of Thomson Cooper Accountants, 3 Castle Court, Carnegie Campus, Dunfermline, KY11 8PB to be the interim liquidator of the said company with the usual powers, all in terms of said Statute and of Law;

(5) finds the petitioner entitled to the expenses of this process as expenses in the liquidation.
