

**Report by Annette Menzies, Insolvency Practitioner, Liquidator, to the final meeting of creditors held at the offices of William Duncan (Business Recovery) Limited on 2 October 2017 at 10:00am**

- 1 I was appointed to act as Liquidator at the meeting of creditors held on 15 November 2016.
- 2 The Abstract of Receipts and Payments which accompanies the Notice calling this meeting covered the period from the commencement of the Liquidation on 15 November 2016 to 21 August 2017. This indicated that asset realisations were insufficient to make a distribution to the unsecured creditors.

### **Realisations**

- 3 The Statement of Affairs presented at the statutory meeting of creditors advised that the company has no realisable assets. Unfortunately investigations into the business and financial affairs of the company it appear that the company does not have any realisable assets.

### **Administration Expenses**

- 4 Expenses of the Liquidation including Bordereau, Statutory Advertising and Agent's fees totalled £537.

### **Liquidator's Fee**

- 5 Liquidator's fees and expenses carried out in connection with the Liquidation totalled £3,493.20. The Liquidator's fee in this case have been met by a third party.
