IF SUCH A NOTICE HAS BEEN SERVED THE SPECIAL VOTING SHAREHOLDERS SHALL BE ENTITLED (BUT NOT OBLIGED) TO APPOINT AND REMOVE ALL DIRECTORS OF THE COMPANY FOR THE DURATION OF THE SPECIAL VOTING RIGHTS EXERCISE PERIOD. DURING THAT PERIOD HOLDERS OF THE SPECIAL VOTING SHARES SHALL BE ENTITLED TO EXERCISE 90% OF THE TOTAL AVAILABLE VOTING RIGHTS AT ANY GENERAL MEETING (WITH THE TOTAL AVAILABLE VOTING RIGHTS OF ALL OTHER ORDINARY SHAREHOLDERS AT ANY GENERAL MEETING BEING REDUCED ACCORDINGLY) PROVIDED THAT.
