Earth Ways Crowdfunding Platform CIC aims to provide a crowdfunding service to individuals and community organisations for projects that contribute to the general wellbeing of the community, particularly those that promote sustainability, without the fees that are normally charged for these services. Earth Ways Crowdfunding Platform CIC wants all of the resources raised to go to the projects themselves.

Activity this year was again focussed on obtaining enough funds to pay for the costs for the administrative and technological systems required for the website. The previous year, the software provider inconveniently did not upgrade a feature for donations we depend upon for our business model. Which forced us to look for solutions. This year we designed a new website with software from a new provider. We managed to test that website and launch a trial. We intend to launch the website next year.

A total of £478.34 in donations were received from 3 individuals and organisations. The amount raised was used to cover some of the office costs and the necessary software subscriptions and fees. This provided us with the opportunity to redesign our approach and test our new website.

Risk Management

This year, no funds come through the website as the website was shut down. Earth Ways Crowdfunding Platform CIC will only administer the site, being responsible for software subscriptions and other administrative costs required for the effective operation of the site. An income and expenditure statement is produced monthly and is available for inspection by Directors. It is intended to invite new directors to join the company in the coming years.

Investment Policy

Aside from retaining a very small amount in reserves each year, all funds are to be spent in the short term on site maintenance and administration so there are no funds for long term investment.
