

- the Sellers shall:-
- 1.1 not until the Secured Obligations have been satisfied, implemented or paid in full, create nor purport, nor attempt to create nor permit to be created any mortgage, charge, lien (other than a lien arising automatically by operation of law) right of set-off or other security interest or encumbrance over the Security Subjects, nor create nor purport to attempt to create nor permit to subsist any floating charge or debenture over all or any of the assets of the Sellers except in accordance with the terms of the Missives;

- 1.2 not until the Secured Obligations have been satisfied, implemented or paid in full, dispose nor agree to dispose of or part with possession of the Security Subjects with or without the burden of this Standard Security other than to the Purchasers or their nominees in accordance with the Missives, nor shall the Sellers create nor agree to create a subsequent standard security over the Security Subjects or any part thereof;
- 1.3 not be entitled to redeem this Standard Security until the Secured Obligations have been satisfied, implemented or paid in full;
- 1.4 not until the Secured Obligations have been satisfied, implemented or paid in full enter into any negotiations with any local or governmental authority for the compulsory acquisition of the Security Subjects without the consent of the Purchasers (which consent will not be unreasonably withheld);
