The directors present their report and the financial statements for the year ended 30 June 2018.

Directors' responsibilities statement



Independent Auditor's Report to the Members of Hub North Scotland (Elgin High School) Holdings Limited

Opinion

We have audited the financial statements of Hub North Scotland (Elgin High School) Holdings Limited ("the Company") for the year ended 30 June 2018 which comprise the statement of income and retained earnings, the balance sheet and notes to the financial statements, including a summary of significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland (United Kingdom Generally Accepted Accounting Practice).



1. General information

The company is a private company limited by shares and incorporated in Scotland, UK. The company's registered office and company number are disclosed on the company information page. The company's principal activity is as described in the directors' report.

The functional currency used to prepare the financial statements is GBP and they are rounded to the nearest pound.

2. Accounting policies

2.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention unless otherwise specified within these accounting policies and in accordance with Section 1A of Financial Reporting Standard 102, the Financial Reporting Standard applicable in the UK and the Republic of Ireland and the Companies Act 2006.

The preparation of financial statements in compliance with FRS 102 requires the use of certain critical accounting estimates. It also requires management to exercise judgment in applying the company accounting policies (see note 3).

2.2 Valuation of investments

Investments in subsidiaries are measured at cost less accumulated impairment.

In preparing these financial statements, the directors have not had to make any significant judgements in applying accounting policies and there were no sources of estimation uncertainty.
