The authority hereby given may at any time (subject to the said section 551) be renewed, revoked or varied by ordinary resolution.

IT IS RESOLVED THAT pursuant to Section 636 of the Companies Act 2006, 10 of the Ordinary Shares of £1 each comprised in the capital of the company which are issued be converted into, and re-designated as 10 Class A Ordinary Shares of £1 each having the rights and being subject to the conditions set out in the Articles of Association of the company.
