1. Accounting Policies

Basis of accounting

The financial statements have been prepared under the historic cost convention, and in accordance with applicable UK accounting standards and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2015), and the requirements of the Statement of Recommended Practice "Accounting by Limited Liability Partnerships" issued in July 2014 (SORP 2014)

Turnover

Turnover is the total amount of income arising from the LLP's underlying investments.

Investments

Investments shown are recorded at their historic cost less any provision for impairment.

Member's participation rights

Members' participation rights are the rights of a member against the LLP that arise under the members' agreement (for example, in respect of amounts subscribed or otherwise contributed, remuneration and profits).

Members' participation rights in the earnings or assets of the LLP are analysed between those that are, from the LLP"s perspective, either a financial liability or equity. A member's participation rights results in a liability unless the right to any payment is discretionary on the part of the LLP.

Where profits are automatically divided as they arise, so the LLP does not have an unconditional right to refuse payment, the amounts arising that are due to members are in the nature of liabilities.

They are therfore treated as an expense in the Profit and Loss Account in the relevant year within "Members' remuneration charged as an expenses". To the extent that they remain unpaid at the period end, they are shown as liabilities in the Balance Sheet within "Loans and other debts due to members".

Amounts due to members that are classified as Equity are shown in the Balance Sheet within "Members other interests".

All amounts due to members that are classified as liabilities are presented in the Balance Sheet within "Loans and other debts due to members" and are charged to the Profit and Loss Account within "Members remuneration charged as an expense". Amounts due to members that are classified as equity are shown in the Balance Sheet within "Members other interests".

2. Going Concern

The financial statements have been prepared on a going concern basis. The Members have assessed the LLP's ability to continue as a going concern and have reasonable expectation that the LLP has adequate resources to continue in operational exisitence for the forseable future. Thus they continue to adopt the going concern basis of accounting in preparing the financial statements.
