The Manchester Ship Canal Revision Order 1984

Coming into Operation

20th January 1984

The Secretary of State for Transport, in exercise of the powers conferred by section 14 of the Harbours Act 1964(a) and now vested in him(b), and of all other powers enabling him in that behalf, and on the application of the Manchester Ship Canal Company, hereby makes the following Order:—

Citation and commencement

- 1.—(1) This Order may be cited as the Manchester Ship Canal Revision Order 1984 and shall come into operation on 20th January 1984.
- (2) The Manchester Ship Canal Acts and Orders 1885 to 1983 and this Order may be cited together as the Manchester Ship Canal Acts and Orders 1885 to 1984.

Interpretation

- 2. In this Order -
 - "the Company" means the Manchester Ship Canal Company;
 - "the directors" means the directors of the Company;
 - "the docks" means the docks of the Company in the city of Salford known as Docks Nos. 6, 7 and 8;
 - "the harbour" means the harbour and port of Manchester.

Abandonment of docks

- 3.—(1) Subject to the provisions of this article, the Company may, on such date as the directors may by resolution determine, abandon and discontinue all or any of the docks and the Company may—
 - (a) use for the general purposes of the harbour the site of any of the docks so abandoned and, if they think fit, fill it in in whole or in part; or
 - (b) exercise with reference to any of the said docks the powers exercisable by them with reference to surplus lands.
- (2) Within one month of the passing of a resolution of the directors under paragraph (1) of this article, the Company shall give notice of the effect of the resolution by advertisement in such local newspaper as they may deem expedient for causing the resolution to be made known to persons affected thereby.

4. Section 5 (Traffic offences on dock roads) of the Manchester Ship Canal Act 1962(a) is hereby repealed.
