By a written resolution dated 9 November 2021, members representing all of the total voting rights of members who were entitled to vote on the resolution on its circulation date agreed to the following resolution being passed as an ordinary resolution:

Ordinary resolution

That:

- (a) the directors be generally and unconditionally authorised, in accordance with section 551 of the Companies Act 2006, to exercise all powers of the Company to allot shares in the Company or grant rights to subscribe for, or convert any security into, shares in the Company up to a maximum nominal amount of £0.50;
- (b) this authority shall expire at the close of business on 1 December 2021; and
- (c) this authority shall be in addition to all existing authorities under section 551 of the Companies Act 2006.
