Resolution of British Homeopathic Association "the Association"



The trustees resolve to make the following amendments to the Memorandum of Association of the British Homeopathic Association:

- 1. To add a new power to the powers of the British Homeopathic Association set out in the Memorandum of Association to give the power to provide indemnity insurance for trustees out of the Association's funds:
  - "q) To provide indemnity insurance to cover the liability of the Members which by virtue of any rule of law would otherwise attach to them in respect of any negligence, default, breach of trust or breach of duty of which they may be guilty in relation to the company: Provided that any such insurance shall not extend to any claim arising from any act or omission which the Members knew to be a breach of trust or breach of duty or which was committed by the Members in reckless disregard to whether it was a breach of trust or a breach of duty or not and provided also that any such insurance shall not extend to the costs of any unsuccessful defence to a criminal prosecution brought against the Members in their capacity as directors of the company."
- 2. To replace the clause <u>Disposal of Income and Property</u> with the new clause set out below:

The income and property of the Association shall be applied solely towards the promotion of the objects and no part shall be paid or transferred directly or indirectly by way of dividend, bonus or otherwise by way of profit, to the Members of the Association, and no Member shall be appointed to any office of the Association paid by salary or fees or receive remuneration or other benefit in money or money's worth from the Association: Provided that nothing in this document shall prevent any payment in good faith by the Association:

1. of reasonable and proper remuneration for any services rendered to the Association by any officer or servant of the Association who is not a Member of the Council;

- 2. of interest on money lent by any Member of the Association at a reasonable and proper rate per annum not exceeding 2 per cent less than the published base lending rate of a clearing bank to be selected by the Members;
- 3. of reasonable and proper rent for property demised or let by any Member of the Association;
- 4. to any Member of reasonable out-of-pocket expenses;
- 5. of any premium in respect of any indemnity insurance to cover the liability of the Members which by virtue of any rule of law would otherwise attach to them in respect of any negligence, default, breach of trust or breach of duty of which they may claim to be guilty in relation to the Association: Provided that any such insurance shall not extend to any claim arising from any act or omission which the Members knew to be a breach of trust or breach of duty or which was committed by the Members in reckless disregard to whether it was a breach of trust or breach of duty or not and provided also that any such insurance shall not extend to the costs of an unsuccessful defence to a criminal prosecution brought against the Members in their capacity as Members of the Association."
