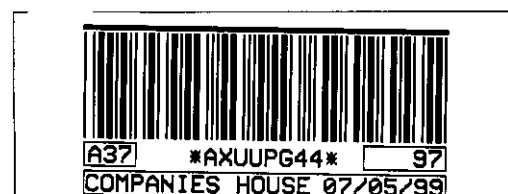

## NOTES
