#### LIQUIDATOR'S ACTIONS SINCE LAST REPORT

Since my last report to creditors, I have been awaiting confirmation from The Insolvency Service that they have concluded all their investigations and authority to dose my files. This was confirmed to me on 29 January 2018.

#### RECEIPTS AND PAYMENTS ACCOUNT

My Receipts and Payments account for the period 24 February 2016 to 6 February 2018 is attached at Appendix 1.

Estate funds were banked in a designated dients' account at a UK bank and accordingly there is no account held by the Secretary of State to which the attached report can be reconciled to.

#### **ASSETS**

#### Book debts

The Statement of Affairs advised of book debts totalling £42,000 which after a provision of 20% was taken meant that it was estimated that the book debts would realise £33,600.

The Director has not provided any assistance or invoices to allow these book debts to be recovered.

Following extended attempts by my office to ensure cooperation the matter was handed over to solicitors. Following the Director not responding to the solicitor's correspondence, a tracing agent was used to establish that the Director resided at the address I had in my records. The Solicitor conduded that whilst proceedings against the Director were possible to enforce cooperation it appears unlikely on the facts provided that creditors would benefit from such action. The book debts have therefore been written off.

#### Bank Interest

During the course of the liquidation, the funds received have been place on an interest-bearing account and the sum of 55p has been received.

#### LIABILITIES

#### Secured Creditors

An examination of the Company's mortgage register held by the Registrar of Companies, showed that the Company has no current charges over its assets.

The legislation requires that if the Company has created a floating charge after 15 September 2003, a prescribed part of the Company's net property (i.e. the money that would otherwise be available to the charge holder) should be ring-fenced for distribution to unsecured creditors. In this case there were no secured creditors and accordingly the prescribed part provisions do not apply.

#### Preferential Creditors

No preferential daims were anticipated and none have been received.

#### Unsecured Creditors

Seventeen unsecured creditors were listed in the Statement of affairs, owed an estimated £464,275.71. I have received seven unsecured daims totalling £143,364.06.

#### DIVIDENDS

#### Unsecured Creditors

A dividend will not be paid to unsecured creditors as the funds realised have been used to meet the expenses of the Liquidation.

#### Prescribed Part

The Company did not grant a floating charge to any creditor and accordingly the prescribed part provisions will not apply.

#### INVESTIGATION INTO THE AFFAIRS OF THE COMPANY

I undertook an initial investigation into the Company's affairs to establish whether there were any potential asset recoveries or conduct matters that justified further investigation, taking account of the public interest, potential recoveries, the funds likely to be available to fund an investigation, and the costs involved.

There were no matters that justified further investigation in the circumstances of this appointment.

Within three months of my appointment, I was required to submit a confidential report to the Secretary of State to include any matters which have come to my attention during the course of my work which may indicate that the conduct of any past or present director would make him unfit to be concerned with the management of the Company. I confirm that my report has been submitted.

#### PRE-APPOINTMENT REMUNERATION

The creditors previously authorised the payment of a fee of £5,000 plus VAT and disbursements to Sharma & Co for assistance with the preparation of the statement of affairs and producing and circulating the notices for the meetings of members and creditors prior to my appointment at a meeting held on 24 February 2016. I understand this fee has been paid to Sharma & Co.

#### LIQUIDATOR'S REMUNERATION

My remuneration was previously authorised by creditors at a meeting held on 24 February 2016 to be drawn on a time costs basis. The time spent to date is 32.5 hours at a cost of £4,715.00 net of VAT, of which 11.9 hours have been charged in the last twelve months at a cost of £1,933.00 net of VAT. Time is charged in minimum units of six minutes. I have drawn fees totalling £1,900 plus VAT, none of which has been drawn in the last twelve months.

A description of the routine work undertaken in the liquidation since my last report is as follows:

#### 1. Administration and Planning

- Dealing with all routine correspondence.
- Maintaining physical case files and electronic case details.
- Review and storage.
- Case bordereau.
- Case planning and administration.

#### 2. Cashiering

- Maintaining and managing the liquidator's cashbook and bank account.
- Ensuring statutory lodgements and tax lodgement obligations are met.

#### 3. Creditors

- Preparing reports to creditors.
- · Maintaining creditor information.

#### 4. Investigations

 Liaising with The Insolvency Service regarding their report and receiving authority to close my files.
