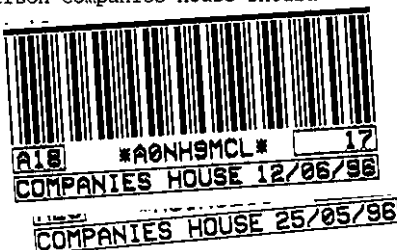

## NOTES
