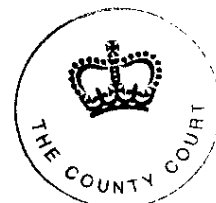
AND UPON the Claimant by his Solicitors undertaking to:

IT IS ORDERED THAT:

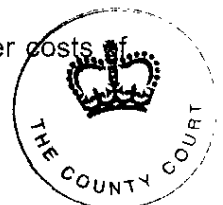
(1) the name of the above named Smith & Nephew Lilia Limited be restored to the Register of Companies
