

## Notes to the Financial Statements

### 1. Accounting policies

#### Basis of preparation

In previous years, the financial statements have been prepared on a going concern basis under the historical cost convention, in accordance with the Companies Act 2006 and applicable accounting standards in the United Kingdom. As the directors intend to dissolve the company at a future date, the directors have not prepared the financial statements on a going concern basis. No additional adjustments were necessary to the amounts at which the remaining net assets are included in these financial statements. The principal accounting policies, applied consistently throughout the year, are set out below.

#### Statement of compliance

The individual financial statements of Merial Animal Health Limited have been prepared in compliance with United Kingdom Accounting Standards, including Financial Reporting Standard 102, "The Financial Reporting Standard applicable in the United Kingdom and the Republic of Ireland" ("FRS 102") and the Companies Act 2006. The exemption under paragraph 35.10(m) of FRS102 for dormant entities has been applied.

#### Related party transactions

The company discloses transactions with related parties which are not wholly owned with the same group. It does not disclose transactions with members of the same group that are wholly owned.

### 2. Profit and loss account

The company did not trade and has made neither profit or loss nor any recognised gain or loss during either the current or preceding financial year. Accordingly, neither a profit and loss account nor a statement of comprehensive income has been presented. The company had no employees in the year (2021: *nil*) other than its directors who received no remuneration for their services to the company.
