# SPECIAL WRITTEN RESOLUTION OF THE SHAREHOLDERS OF THE COMPANY

- **1. THAT** the articles of association of the Company be amended as follows:
- 1.1 deleting Article 12 in its entirety and replacing with the following:

"Article 12 [Unused]"; and

- 1.2 the words "Subject to Article 12.1" are deleted from the first sentence of Article 14.1; and
- 1.3 a new Article 14.2 immediately following Article 14.1 is inserted as follows:

"Notwithstanding anything to the contrary in these Articles and in the Model Articles, the directors of the Company will register any transfer of shares and may not suspend registration of such shares where such transfer:

# 14.2.1 is to:

- 14.2.1.1 a bank or financial institution or to a trust, fund or other entity which is regularly engaged in or established for the purpose of making, purchasing or investing in loans, securities or other financial assets or to an affiliate thereof (for purposes of these articles, any such entity a "Financial Institution") or an agent or trustee for any Financial Institution where a security interest has been or is purported to be granted over those shares (for purposes of these articles, each a "Security") that benefits a Financial Institution; and/or
- 14.2.1.2 a company or other entity to whom such shares are transferred at the direction of a Financial Institution and/or any administrative receiver, administrator, receiver or receiver and manager or similar entity (a "Receiver") pursuant to powers granted to it under the Security;
- 14.2.2 is delivered to the Company for registration in order to perfect or protect any Security of a Financial Institution; or
- 14.2.3 is executed by a Financial Institution or Receiver pursuant to a power of sale or other such power under any Security."
