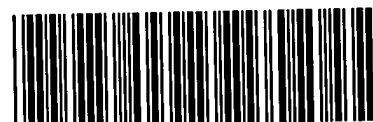

- (9) the benefit of: (i) the right to be included in any pharmaceutical list prepared and kept by the Health Board (as defined in the National Health Service (Scotland) Act 1978 pursuant to the National Health Service (Pharmaceutical Services) (Scotland) Regulations 2009 (as amended), and (ii) any and all contracts or agreements for the sale or supply of products or services by the Chargor to nursing homes or residential care homes or to other customers of the Business entered into by the Chargor in the ordinary course of the Business and not other retail pharmacy or business owned or run by the Chargor or the Chargor's group.
