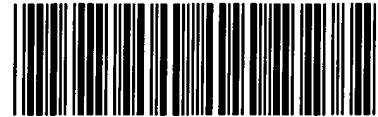

- (3) the retail pharmacy business carried on by Lloyds Pharmacy Limited ("Chargor") from the Properties as at 12 May 2023 ("Business");
- (4) the goodwill of the Chargor in connection with the Business at the Properties;
