





Add to the Property Charge the words "together with all buildings, fixtures (including trade fixtures) and fixed plant and machinery from time to time on the property, and the goodwill of any business carried on thereon together with the benefit of any Licences and Registrations required in the running of such business".
- 3. We Undertake to amend the Legal Charge of the 22nd February 1995 by deleting reference to 18 Avon Road West Christchurch and reinstating in the Schedule Flat 21 Woodland Park Constitution Hill Gardens Poole Dorset.
