The declaration of solvency, sworn by the directors prior to the commencement of the liquidation, showed a debt of approximately £196,000 due from Alvis Limited (the '**Debt'**). The actual amount of the Debt is £195,591.21, which will be distributed by assignment to BAE Systems Land Systems (Finance) Limited, the Company's sole shareholder.

Creditors

The Company had no known creditors. As reported previously, a notice to creditors to prove their claims in the liquidation was advertised in the London Gazette on 20 January 2020 and no creditors were forthcoming.

Tax

All pre-liquidation corporation tax matters were handled by BAE Tax who prepared and submitted all outstanding returns up to the date of the commencement of the liquidation to HM Revenue & Customs ('HMRC'). At the request of the Joint Liquidators, HMRC subsequently confirmed that the Company had no outstanding

corporation tax returns or liabilities, that it would not raise enquiries into any pre or post liquidation periods and that it had no objection to the Joint Liquidators taking steps to bring the liquidation to a conclusion.

A similar assurance was sought and received on 26 January 2022 from HMRC in respect of PAYE and VAT matters.

Distributions

No distributions have been declared to date.

Joint Liquidators' remuneration and expenses

A written resolution was passed on 7 January 2020 that the remuneration of the Joint Liquidators be fixed at their normal charging rates according to the time properly spent by them and members of their staff in attending to matters arising in the winding up of the Company.
