1.1. Basis of Preparation of Financial Statements

The financial statements have been prepared under the historical cost convention and in accordance with Financial Reporting Standard 102 section 1A Small Entities "The Financial Reporting Standard applicable in the UK and Republic of Ireland" and the Companies Act 2006

1.2. Turnover

Revenue recognition

The company acts as a trustee of a statutory trust in respect of service charges collected for the maintenance of properties at All Saints Court, All Saints Road Bristol.
